9 WHEREAS, The Chief of Police of the City and County of San Francisco desires to

2 augmentations from the California Emergency Management Agency; and, be it


3 FURTHER RESOLVED, that the Board of Supervisors hereby waives inclusion of

9 of this Grant Award Agreement, including civil court actions for damages, shall be the
10 responsibility of the City and the San Francisco Police Department; and be it

11 FURTHER RESOLVED, that grant funds received hereunder shall not be used to
12 supplant expenditures controlled by this body.





II. OVERALL

Overall Purpose of Investment:

Pursuant to Public Law 110-329, the Consolidated Security, Disaster Assistance, and Continuing Appropriations Act of 2009, Congress explicitly allocated \$1,000,000 to the San Francisco Police Department in non-competitive funding from the Emergency Operations Center Grant Program. This award was further confirmed in the April 9, 2009- Grant Programs Directorate Information Bulletin No. 311 from the Federal Emergency Management Agency (FEMA), see attached page, A-13, of the this document.

This project investment will improve countywide emergency management and preparedness capabilities by addressing identified deficiencies and needs while providing the means to conduct emergency management.

The San Francisco Police Department (SFPD) exchanges information with other city agencies and governmental and non-governmental agencies in order to maintain a comprehensive situational awareness. It also serves as City and County of San Francisco's Multi-Agency Coordination Center (MACC), as described in NIMS, thereby ensuring that all response systems are interconnected and complementary. The San Francisco Police Department's facility has been the key operations center during large scale events (SF Marathon, Olympic Torch Run, Halloween and New Year's Eve) where all impacted department heads or representatives gather for the operational period.

The San Francisco Police Department Operations Center is an operational/logistical entity that is designed to serve as a departmental and City and County of San Francisco coordinating body in support of Incident Management. The SFPD has two primary responsibilities during planned and unplanned events: 1) to maintain internal departmental operations (Continuity of Operations) and, (2) when necessary, to contribute to citywide response through communication and coordination.

III. NEEDS ASSESSMENT

Needs Assessment:

The SFPD currently does not have a fully constructed and dedicated facility that serves as the central point of coordination for major emergencies or planned/unplanned events. The current facility location at Pier 96 is not equipped due to the lack of security. The equipment is stored in another location - Special Operation Security Division, Building 606. When activated, the equipment is moved to Pier 96 in order to become fully functional. Under the current system, it would take up to three hours to respond and make the center fully operational in an emergency

During emergency incidents and events, the San Francisco Police Department Emergency Operations Center receives resource requests, prioritizes and manages departmental resources, maintains departmental operations (such as staffing, finance, intra-departmental planning) and coordinates with other San Francisco department heads that are present at the facility or off site.

The Homeland Security Unit, Tactical Unit, EOD Unit and Crime Lab are currently located in Building 606 at the Hunters Point Shipyard. The Police Department is required to relocate to accommodate the ongoing development of the Shipyard. The Police Department's Homeland Security Unit, Tactical and EOD are moving into an existing building at a new location (see below). Due to the importance of maintaining a "green" city and due to the lack of space for a new construction, a location was found that suites the department's needs and that of the terms of the EOC Grant. The "footprint" of the selected building was changed during the construction of the facility. The building was made into one building from two separate building structures. An addition of a mezzanine level was added to the building with steel bollards placed in the walls to secure the location of the Operations Center.

This new location is at 1700-1740 17th Street and 1415 16th Street in San Francisco. Initial floor plans developed by the City and County of San Francisco Real Estate Division outlined approximately 2,835 square feet expandable to 5,735 square feet within the building as part of a needs assessment that was conducted on November 4, 2008 by the San Francisco Police Department. The space is secure and ideal for a dedicated San Francisco Police Department Operations Center. Significant public outreach was performed prior to bringing this lease to the Board of Supervisors for review and approval.

IV. INVESTMENT IMPACT

Investment Impact:

The City and County of San Francisco All-Hazards Strategic Plan 2008 is intended to enhance the City's ability to deter, prevent, respond to, and recover from acts of terrorism and natural and human-caused disasters through development of a single, common preparedness vision and strategy. The Strategic Plan provides overarching goals and is supported by the Implementation Roadmap. The ability to implement planned activities successfully depends greatly on adequate funding, availability of trained and experienced personnel, political will, and adequate facilities.

The current logistics involved in order to activate our present center is both time consuming and taxing on personnel when the need is greatest. A permanent facility, at a more central location, fully equipped with immediate functionality, and housed within a secure facility with immediate access to the departments mobile Command Centers, provides a greater enhancement to our

emergency management capabilities and for the City and County of San Francisco. This investment will be cost effective with less personnel costs for activation, less use of fossil fuels to transport equipment, and a more timely activation.

V. PRE-EXISTING PLANNING

Pre-Existing Planning

Facility Assessment:

In 2006, the San Francisco Redevelopment Agency notified the SFPD that it must remove all equipment and personnel from their current location at Building 606 as soon as possible to allow for the planned redevelopment of the Hunter's Point Naval Shipyard. The SFPD Homeland Security Unit and Tactical Company are currently at that location.

The Redevelopment Agency and the SFPD reviewed 21 potential sites which did not satisfy location specifications. Members of the Redevelopment Agency and the Police Department selected the subject sites at 1700-1740 17th Street and 1415 16th Street because the space (a) meets the space requirements of the Tactical Company, (b) the property owner has provided a substantial tenant improvement allowance and the ability to amortize improvement costs in excess of the tenant improvement allowance, and (c) the Landlord (1415 16th Street Associates) is also a contractor (O'Keefe Construction), and, as such, the Landlord has agreed to provide all resources available, such as subcontractors, labor, and materials, to expedite the time required to complete the tenant improvements. Architectural Plans were drawn up in September 2008. On October 21, 2008, the Lease Agreement was approved by the Local Governing Body, and on February 4, 2009, the permit for construction was approved.

Existing SFPD facility deficiencies were addressed in the new facility assessment and architectural plans in order to a dedicated physical space for a permanent San Francisco Police Department Emergency Operations Center.

Hazard Resistance Guidance: The design criteria addresses relevant hazards. The site has been evaluated and will include seismic upgrades due to the strong likelihood that San Francisco will experience a catastrophic seismic event. The SFPD EOC is strategically located and away from wind and water vulnerabilities.

The exterior has undergone an assessment in order to harden the building perimeter to man-made attack. Specialized hardened infrastructure will be added to the exterior. A video surveillance system, lighting, restricted parking, swipe card access, and patrols in the area will secure the area near the facility. These systems are included in the matching/in-kind match provided by the city.

VI. FUNDING PLAN

All submitted funding requests are in accordance with the EOC Guidelines as described in part IV, section E, "Funding Restrictions." The submitted funding plan also reflects the SFPD's 25 percent/in-kind "Cost Sharing" as described in Part III, section B.

VII. FUNDING SOURCES

Supplemental Funding:

The City will pay all costs for utilities and janitorial services under the lease. Utilities and janitorial services for the entire building are estimated to be approximately \$569,354 annually (\$456,277 utilities annually plus \$113,077 DPW custodial services annually), or \$47,446 per month for all services. The SFPD EOC is 5% of the entire building and when activated can be expanded to 10%. The annual cost for maintenance for just the primary is approximately \$28,467. There would be a one-time cost for telecommunications equipment and installation at the site, estimated to be \$371,990 (provided by the Department of Technology). The costs for such equipment and installation are being reprogrammed for this purpose in our FY09 budget.

VIII. INVESTMENT CHALLENGES

Investment Challenges:

Initial planning, site selection, seismic issues, permit approvals, and logistical challenges have already been met and resolved prior to implementation of this investment. However, recognized challenges are:

1. Administering the Accept & Expend process for approval of local governing body (San Francisco Board of Supervisors). This step is required and sometimes faces delays during the political process to ensure both programmatic and fiscal goals are met. On occasion, local budget shortfalls occur and priority projects may face delays. In this investment, match funding sources have already been identified and secured. Probability of occurrence is low.
2. Obtaining successful equipment bids in compliance with federal purchasing requirements can be a challenge because of City purchasing restrictions and rules for vendors. The SFPD has

been successful in addressing these challenges in the past in order to successfully complete vendor contracts. However, time delays often occur. Probability of occurrence is medium.

3. Frequent change-orders for both construction and equipment can be a challenge when attempting to meet timetables and milestones. Attempts will be made to lessen this issue through proper research and coordination prior to construction or equipment ordering. Probability of occurrence is low.

4. Timely coordination and collaboration between building owner, contractors, the City, vendors, and installers is always a challenge. Many of these concerns have been mitigated through the lease agreements for build-out of the overall space. It is critical that after the construction is completed all parties concerned make every attempt to keep with established timetables for successful investment implementation. Probability of occurrence is medium.

5. Changes in personnel assigned to project management are always a challenge when investments of this time duration are involved. It is incumbent on all command staff to ensure that as staffing changes all parties concerned are properly briefed to ensure successful investment implementation. Probability of occurrence is medium.

6. Competition for resources, people and time against other organization needs have a high probability of occurrence in a public service environment. However, this challenge is less here given the emergency needs and probability of frequent use of the new facility. Probability of occurrence is medium.

IX. PROJECT MANAGEMENT

Project Management:

The Police Department is divided into four major Bureaus; Investigations, Administration, Airport and Field Operations. The Homeland Security Unit is under Field Operations. The management team for this project will include the Commander and Lieutenant of the Homeland Security Unit for implementation. They will utilize Departmental capabilities and personnel's expertise as the needs arise to implement this project. Participating units will be the Planning Division (facilities), IT (telecommunications specialties), Fiscal Division (financial), County Department of Emergency Management, and Special Operations Unit (technical expertise).

X. MILESTONES

10 Major Milestones for Completion of the EOC:

Anticipated 36 month period of performance 10/1/2009 to 9/30/2012.
