14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. The Board of Supervisors hereby adopts and implements the Memorandum  
16 of Understanding (“MOU”) between the City and County of San Francisco and the Machinists  
17 Union, Local 1414, International Association of Machinists & Aerospace Workers Machinists  
18 Automotive Trades District Lodge 190 to be effective July 1, 2024 through June 30, 2027.

19 The MOU so implemented is on file with the Clerk of the Board of Supervisors in Board  
20 File No. 240523.

21 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
22 Resources to make non-substantive ministerial or administrative corrections to the MOU.

23 Section 3. Effective Date. This ordinance shall become effective upon enactment.  
24 Enactment occurs when the Mayor signs the ordinance, the Mayor returns the ordinance

1 unsigned or does not sign the ordinance within ten days of receiving it, or the Board of  
2 Supervisors overrides the Mayor's veto of the ordinance.


