8 Quake and the destruction and rebirth of San Francisco in events across the City and region;

10 WHEREAS, The commemoration of San Francisco Rising is important to honor our
11 City's history and to encourage future emergency preparedness; and,

12 WHEREAS, The events of April 18th could not happen without the cooperation and
13 leadership of many City Agencies; and

14 WHEREAS, The Municipal Transportation Agency (MTA) was particularly creative and
15 responsive in planning for the events, including the 4:30 AM ceremony at Lotta's Fountain,
16 the Market Street Parade, the Earthquake Expo and the resulting MUNI re-routes, street
17 closures, and parking impacts; and

18 WHEREAS, MTA staff led by Nathaniel Ford, Joyce Garay, Cindy Shamban, Sylvia
19 Harper, Ron Szeto, Maggie Lynch, Jim Kelly and Anne Richman worked diligently to ensure
20 that the citizens of San Francisco, and all who came to observe the Centennial had free
21 access to transportation despite the need to reroute over 20 affected bus lines and close
22 multiple streets; and

23 WHEREAS, The MTA provided 24 hours of free MUNI service from 3am on April 18th
24 to 3am on April 19th; now, therefore, be it




