7 **WHEREAS,** The City and County of San Francisco (City), under the terms of three separate
8 court issued Orders for Immediate Possession, has taken possession of San Francisco Assessor's
9 Block 3724, Lots 18, 35, 36, 37, 38, 68, 69 and 70, together with the improvements thereon for the
10 Moscone Center Expansion Project (Project); and

11 **WHEREAS,** the City proposes to vacate Holland Court and a portion of Minna Street for the
12 purpose of incorporating such area into the Project site; and

13 **WHEREAS,** The proposed area of Holland Court and Minna Street to be vacated are shown
14 on the Department of Public Works SUR Drawing No. 898, dated April 27, 1999, a copy of which is
15 on file in the Office of the Clerk of the Board of Supervisors; and

16 **WHEREAS,** By letter dated April 27, 1999, a copy of which is on file in the office of the
17 Clerk of the Board of Supervisors, the Department of Public Works reported its finding that the
18 proposed area of Holland Court and Minna Street to be vacated is no longer needed for present or
19 prospective street purposes, subject to the approval and completion of the Project; and

20 **WHEREAS,** By Planning Commission Motion No. 14557 adopted March 12, 1998, a copy
21 of which is on file in the Office of the Clerk of the Board of Supervisors, the Department of City
22 Planning adopted findings related to the appeal of the Negative Declaration, File Number 96.099E,
23 and affirmed the decision to issue a Negative Declaration for the Project; and

1 **WHEREAS**, By Planning Commission Resolution No. 14559 adopted March 12, 1998, a
2 copy of which is on file in the Office of the Clerk of the Board of Supervisors, the Department of
3 City Planning adopted findings that the proposed vacation of Holland Court and a portion of Minna
4 Street is in conformity with the City's General Plan and with the Eight Priority Policies of City
5 Planning Code Section 101.1; now, therefore, be it:

6 **RESOLVED THAT**, Pursuant to Section 8320 of the Streets and Highway Code, it is hereby
7 declared that it is the intention of the Board of Supervisors to order the vacation of Holland Court and
8 a portion of Minna Street as described in the aforesaid drawing on file in the office of the Clerk of the
9 Board of Supervisors; and be it

10 **FURTHER RESOLVED**, That the vacation proceeding of said street is conducted under the
11 general vacation procedures of the Public Streets, Highways and Service Easements Vacation Law
12 (Streets and Highway Code Section 8320 et seq.); and be it

13 **FURTHER RESOLVED**, That notice is hereby given that on the 16th day of
14 August, 1999, beginning at 7:00 ~~3:00~~ p.m. at Balboa High School, 1000 Cayuga Avenue
15 ~~in the Legislative Chambers of the Board of~~
16 ~~Supervisors~~, all persons interested in or objecting to the proposed vacation will be heard; and be it

17 **FURTHER RESOLVED**, All actions authorized by this resolution and heretofore taken by
18 any City official in connection with the vacation contemplated herein are hereby ratified, approved
19 and confirmed by this Board of Supervisors, and be it

20 **FURTHER RESOLVED**, That the Clerk of the Board of Supervisors is hereby directed to
21 transmit to the Department of Public Works, a certified copy of this Resolution, and the Department
22 of Public Works is hereby directed to publish or post this Resolution in the manner required by law




