6 WHEREAS, Project Read is a program of the Public Library that
7 helps adults with low literacy rates improve their skills; and,

8 WHEREAS, Project Read wishes to increase their intergenerational
9 programming in Family Literacy, assisting parents and children to
10 learn and improve literacy skills together which has a positive
11 impact on a child's ability to do well in school ; and,

12 WHEREAS, The California State Library and through that agency,
13 Children and Families State Commission (Prop 10), wishes to fund
14 Family Literacy Programs in Libraries; and,

15 WHEREAS, To maximize use of available grant funds on program
16 services the Public Library proposes that indirect funds be waived;
17 now, therefore, be it

18 RESOLVED, That the Public Library be authorized to accept and
19 expend a grant in the amount of \$69,000 from the California State
20 Library for enhancing family literacy programming as part of Project
21 Read; and be it

22 FURTHER RESOLVED, That the Board of Supervisors hereby waives
23 inclusion of indirect costs in the grant budget.


