3 **Ordinance authorizing settlement of the lawsuit filed by Edwin Jesus Rementeria**  
4 **Hidalgo against the City and County of San Francisco for \$70,000; the lawsuit was filed**  
5 **on September 9, 2024, in San Francisco Superior Court, Case No. CGC-24-617912;**  
6 **entitled Edwin Jesus Rementeria Hidalgo v. City and County of San Francisco and**  
7 **Drew Raymond Jackson; the lawsuit involves alleged personal injury from a vehicle**  
8 **collision.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
12 authorizes the City Attorney to settle the action entitled Edwin Jesus Rementeria Hidalgo v.  
13 City and County of San Francisco and Drew Raymond Jackson, San Francisco Superior  
14 Court, Case No. CGC-24-617912 by the payment of \$70,000. The lawsuit involves alleged  
15 personal injury from a vehicle collision.

16 Section 2. The above-named action was filed in San Francisco Superior Court on  
17 September 9, 2024, and the following parties were named in the lawsuit: Plaintiff: Edwin  
18 Jesus Rementeria Hidalgo, Defendants: City and County of San Francisco and Drew  
19 Raymond Jackson (#1466).
