5 **San Francisco Superior Court, Case No. CGC 14-541248; entitled Greg Blatman v. City**
6 **and County of San Francisco, et al.; the lawsuit involves an employment dispute.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
10 authorizes the City Attorney to settle the action entitled Greg Blatman v. City and County of
11 San Francisco, et al., San Francisco Superior Court, Case No. CGC 14-541248 by the
12 payment of \$225,000. The lawsuit involves an employment dispute.

13 Section 2. The above-named action was filed in San Francisco Superior Court on
14 August 19, 2014, and the following parties were named in the lawsuit: Plaintiff Greg Blatman;
15 Defendants City and County of San Francisco, and Lorrie Kalos.


