3 **Ordinance authorizing settlement of the portion of the lawsuit filed by Vladimar Belfor**
4 **and Victor Kanevsky against the City and County of San Francisco for \$34,000; the**
5 **lawsuit was filed on January 31, 2005, in San Francisco Superior Court, Case No.**
6 **436930; entitled Jane Martin, et al. v. City and County of San Francisco, et al.**

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to co-plaintiffs Vladimar Belfor and Victor
11 Kanevsky, by the payment of \$34,000, and excluding the claim by these plaintiffs for
12 diminution of property value, attorney's fees, costs and interest, which will be addressed in
13 later proceedings.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs
16 Vladimar Belfor and Victor Kanevsky and Defendant City and County of San Francisco.
