4 **Resolution authorizing the San Francisco Department of Public Health (SFDPH) to**  
5 **enter retroactively into a subcontract agreement in the amount of \$20,000 with the**  
6 **Regents of the University of California, AIDS Research Center (UCARC) to collaborate**  
7 **in efforts to assess unmet needs for primary care by persons receiving AIDS services**  
8 **in San Francisco; for the period of April 10, 2001 to April 9, 2002.**

10 WHEREAS, The SFDPH has received funds from the UCARC under its award by the  
11 federal Health Resources and Services Administration (HRSA) for a project entitled  
12 "Estimating Unmet Need for HIV Care"; and,

13 WHEREAS, The UCARC has requested that the SFDPH enter into a subcontract  
14 agreement to participate in the HRSA project by collaborating in an effort to estimate unmet  
15 need for primary care on the part of persons receiving AIDS services in San Francisco; and,

16 WHEREAS, The UCARC has agreed to reimburse the SFDPH in the amount of  
17 \$20,000 under the terms of this subcontract; and,

18 WHEREAS, As a condition of receiving the funds the UCARC requires the SFDPH to  
19 enter into an agreement (The "Agreement"), a copy of which is on file with the Clerk of the  
20 Board of Supervisors in File No. 011725, which is hereby declared to be a part of this  
21 resolution as if set forth fully herein; and,

22 WHEREAS, The subcontract budget includes provision for indirect costs of \$2,143;  
23 now, therefore, be it

1 RESOLVED, That the SFDPH is hereby authorized to enter retroactively into a  
2 subcontract agreement in the amount of \$20,000 with the UCARC, the primary contractor;  
3 and, be it

4 FURTHER RESOLVED, That the SFDPH is hereby authorized to accept and expend  
5 the contract funds in accordance with the requirements set forth in the Agreement pursuant to  
6 San Francisco Administrative Code section 10-170-1; and, be it


7 FURTHER RESOLVED, That the Director of Health is authorized to enter into the


