

1 [Resolution authorizing the Library to accept and expend a bequest from John Fortunio.]

3 **Resolution authorizing the San Francisco Public Library to accept and expend a gift in**
4 **the amount of \$158,947 from the estate of John Fortunio.**

6 WHEREAS, The Will of John B. Fortunio, deceased, bequeathed a portion of his estate
7 as follows:

8 One third (1/3) of the residue of the estate to the Laguna Honda Home to be used for
9 the purchase of food, clothing, medicine, entertainment equipment and other articles;

10 One third (1/3) of the residue to the San Francisco General Hospital Aids Ward to be
11 used for the purchase of food, clothing, medicine, entertainment equipment and other articles;
12 and

13 One third (1/3) of the residue in equal shares to the University of San Francisco and
14 the San Francisco Public Library for the purchase of books, the making of capital
15 improvements, the improvement of their library plants or for the purchase of audio visual
16 equipment; and

17 WHEREAS, the residue of John B. Fortunio's estate consisted of real property and
18 cash as follows:

19 A) A four unit apartment building located at 2110-2112 Pine Street and also known as
20 Assessor's Block 652, Lot 7A;

21 B) A one-half (1/2) interest in a 4-unit apartment located at 365 Haight Street and also
22 known as Assessor's Block 858, Lot 23; and

23 C) Cash in the approximate amount of \$350,000 (less any Court-approved estate
24 expenses); and


1 WHEREAS; in the Spring of 1994, under Resolution No. 245-94 on file with the Clerk of
2 the Board of Supervisors in File No. 38-94-2, the Board of Supervisors authorized the
3 Director of Property to accept the real property and cash and to "manage the properties until
4 such time as such properties can be sold and the proceeds therefrom distributed" to the
5 above-mentioned departments;

6 WHEREAS, The proceeds of the sale of the real estate and any other monies
7 remaining are now being distributed to the beneficiaries; and,


8 WHEREAS, The portion of the bequest allocated to the San Francisco Public Library
9 totals \$158,947; now, therefore, be it

10 RESOLVED, That the San Francisco Public Library be authorized to accept and
11 expend \$158,947 which comprise the proceeds from the Estate of John B. Fortunio.


