8 **and County of San Francisco, in accordance with Section 23958.4 of the**  
9 **California Business and Professions Code, with conditions.**

11 WHEREAS, Jay N. Gospodnetich and James M. Robinson are seeking transfer  
12 of a Type 21 off-sale general license and the issuance of a Type 42 on-sale beer and  
13 wine public premises license for J.G.C.J. Wine Group, LLC, dba Wine Styles, located at  
14 9 West Portal Avenue; and,

15 WHEREAS, The Planning Department has verified that the area is properly  
16 zoned and recommends approval with conditions; and,

17 WHEREAS, The Police Department recommends that the liquor license  
18 application be approved with conditions; now, therefore, be it

19 RESOLVED, That in accordance with Section 23958.4 of the California Business  
20 and Professions Code, the Board of Supervisors of the City and County of San  
21 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21  
22 off-sale general license from 3130 Noriega Street to 9 West Portal Avenue and the  
23 issuance of a Type 42 on-sale beer and wine public premises license to Jay N.  
24 Gospodnetich and James M. Robinson, will serve the public convenience and necessity  
25 of the people of the City and County of San Francisco.

1           Conditions: 1) Sales and service of alcoholic beverages shall be permitted only  
2 between the hours of 9:00 a.m. to 9:00 p.m. each day of the week. 2) Petitioners shall  
3 not permit their patrons or the general public to loiter or congregate on the sidewalks  
4 adjacent to the licensed premises. 3) The petitioner(s) shall be responsible for  
5 maintaining free of litter the area adjacent to the premises over which they have control.  
6 4) There shall be no coin operated games or video machines maintained upon the  
7 premises at any time. 5) No noise shall be audible beyond the area under control of the  
8 license. 6) The sale of any beer and/or malt product(s) is strictly prohibited.


