MANDATE STATEMENT

City Charter Section 9.105 states that amendments to the Annual Appropriations Ordinance, after the Controller certifies the availability of funds, are subject to Board of Supervisors approval by ordinance.

BACKGROUND

The FY 2023-24 – FY 2024-25 Annual Appropriation Ordinance included a \$10 million General Fund set-aside in the General City Responsibility cost center to cover expenses related to the Asian Pacific Economic Conference (APEC), which took place in San Francisco in November 2023. The account was placed on Budget & Finance Committee reserve during the Board phase of the June budget process. In January 2024, the Budget & Finance Committee approved the release of \$6.5 million from the APEC reserve to reimburse expenditures incurred by the Police, Sheriff, and Emergency Management Departments during APEC.¹ There remains \$3.5 million in the APEC reserve.

DETAILS OF PROPOSED LEGISLATION

The proposed ordinance would de-appropriate \$3.5 million from the General City Responsibility APEC reserve and re-appropriate \$3 million to the Office of Economic & Workforce Development (OEWD) and \$500,000 to the Municipal Transportation Agency (MTA).

Relief Funds

According to the proposed ordinance, \$2 million will be provided to OEWD to provide support to SOMA area businesses and organizations impacted by APEC. An additional \$1 million will be provided to OEWD to fund a transit impact relief fund for small businesses.

According OEWD, no rules have been developed for either the APEC or transit impact relief programs. The Board of Supervisors should request OEWD and the Office of Small Business report back by December 31, 2024 on: (a) the final rules for any new grant program funded by the proposed appropriation, (b) the number of businesses provided grants, and (c) the amount of money disbursed.

Parking and Transit for Lunar New Year Celebrations

The proposed ordinance includes \$115,000 to MTA to offset revenue losses one day of free transit (excluding cable cars) during a Lunar New Year parade on February 24, 2024 and \$180,000 to MTA to offset revenue losses from two hours of free parking in the Portsmouth Square garage for all of February 2024. The values are based on parking activity at Portsmouth Square garage in

February 2022, when the Board of Supervisors funded free parking for Lunar New Year (File 22-0129), and on transit revenues in February 2023. Actual foregone revenues in February 2024 may differ.

Community Ambassadors

The proposed ordinance also included \$205,000 for MTA to fund community ambassador services.

Changes from Original Ordinance

The proposed ordinance incorporates amendments approved at the February 7, 2024 Budget & Finance meeting. The amendments include: increasing the appropriation to OEWD from \$2 million to \$1 million, to fund the transit impact relief fund, and increasing the appropriation to MTA from \$250,000 to \$500,000 to provide \$45,000 in additional funding for transit and parking revenue offsets and \$205,000 for community ambassadors. The amended ordinance also removes language regarding free parking at St. Mary's Square garage.

FISCAL IMPACT

The proposed appropriation will reduce the APEC reserve account to zero.

RECOMMENDATIONS

1. Request OEWD and the Office of Small Business report back by December 31, 2024 on: (a) the final rules for any new grant program funded by the proposed appropriation, (b) the number of businesses provided grants, and (c) the amount of money disbursed.

EXECUTIVE SUMMARY

Legislative Objectives

- The proposed ordinance would de-appropriate \$2.25 million from the General City Responsibility APEC reserve and re-appropriate \$2 million to the Office of Economic & Workforce Development (OEWD) and \$250,000 to the Municipal Transportation Agency (MTA).

Key Points

- In January 2024, the Budget & Finance Committee approved the release of \$6.5 million from the APEC reserve to reimburse expenditures incurred by the Police, Sheriff, and Emergency Management Departments during APEC. There remains \$3.5 million of General Fund monies in the APEC reserve.
- According to the proposed ordinance, the \$2 million for OEWD will be provided to SOMA area businesses and organizations impacted by APEC. As of this writing, an additional appropriation is being considered for businesses impacted by MTA’s Taraval Improvement Project.
- According to the proposed ordinance, the \$250,000 for MTA is to support free parking in the Portsmouth Square and Saint Mary’s Square parking garages and transit fares. According to the Budget & Finance Committee Chair’s Office, the appropriation is intended to offset foregone revenue from waiving parking and transit fees during Lunar New Year, including: (1) two hours of free parking in the Portsmouth Square garage for all of February 2024, (2) two hours of free parking in the St. Mary’s Square garage for all weekends in February 2024, and (3) one day of free transit (excluding cable cars) during a Lunar New Year parade on February 24, 2024. Based on our review of MTA garage and transit activity, we estimate that the foregone revenue could total \$336,050.

Fiscal Impact

According to the proposed ordinance, the \$2 million for OEWD will be provided to SOMA area businesses and organizations impacted by APEC. As of this writing, an additional appropriation is being considered for businesses impacted by MTA’s Taraval Improvement Project. According OEWD, no rules have been developed for either program.

The Board of Supervisors should request OEWD and the Office of Small Business report back by December 31, 2024 on: (a) the final rules for any new grant program funded by the proposed appropriation, (b) the number of businesses provided grants, and (c) the amount of money disbursed.

Transportation

According to the proposed ordinance, the \$250,000 for MTA is to support free parking in the Portsmouth Square and Saint Mary’s Square parking garages and transit fares.² According to the

Budget & Finance Committee Chair’s Office, the appropriation is intended to offset foregone revenue from waiving parking and transit fees during Lunar New Year, including: (1) two hours of free parking in the Portsmouth Square garage for all of February 2024, (2) two hours of free parking in the St. Mary’s Square garage for all weekends in February 2024, and (3) one day of free transit (excluding cable cars) during a Lunar New Year parade on February 24, 2024. Exhibit 1 below shows the breakdown of the foregone revenues.

As shown above, to cover the planned free parking in Chinatown garages and one day of free Muni could cost as much as \$336,050, including a 10 percent buffer, which is \$86,050 more than the proposed \$250,000 appropriation for these purposes. The Board could increase the appropriation to \$336,050 in order to fully cover the projected revenue loss or request MTA absorb a portion of the foregone revenue.

FISCAL IMPACT

If the proposed ordinance is approved, the APEC reserve will be reduced from \$3.5 million to \$1.25 million. Any unspent funds in the APEC will reserve will be available for appropriation in next year’s budget.

RECOMMENDATIONS

1. Request OEWD and the Office of Small Business report back by December 31, 2024 on: (a) the final rules for any new grant program funded by the proposed appropriation, (b) the number of businesses provided grants, and (c) the amount of money disbursed.

Dear Chair Chan and members of the Budget & Finance Committee,

I strongly urge you to please approve the \$1 million re-appropriations request from APEC reserves to small business relief due to L Taraval construction project impacts.

Taraval Street is a diverse neighborhood commercial corridor, with a 100+ mom-and-pop shops and eateries. A majority are owned by first and second generation families, and many are monolingual language speakers.

Like all small businesses, Taraval merchants suffered during the COVID-19 pandemic. But when COVID-19 subsided, the SFMTA's L Taraval Project began construction, leaving many small merchants on the verge of closing-up shop. And the construction has lasted many years now, moving from the western portion of Taraval west of Sunset in Phase A, disrupting all those merchants, and now on the eastern portion of Taraval east of Sunset, disrupting all those merchants.

L Taraval construction has deterred customers due to parking issues, road closures, constant jackhammering and demolition, and lack of business access. Many former customers now head elsewhere and Taraval merchants need relief.

Although I am not a merchant, I am a resident of District 4 who lives a block and a half from Taraval. I find it difficult to park when I try to shop at my favorite stores and restaurants. And I have many friends who are Taraval merchants affected by the construction, and they've told me how bad business has been when the construction has been in front of their places of business.

The city needs to provide Taraval merchants a lifeline. Please approve this \$1 million appropriations request for small business relief from L Taraval construction project impacts.

Dear Chair Chan and members of the Budget & Finance Committee -

My name is Kevin Chen and I am the owner of Sushi Zen Restaurant on Taraval St. between 20th and 21st Ave. The recent SFMTA's L Taraval St. Project has negatively impacted my business. Like all small businesses, we suffered during the COVID-19 pandemic. As COVID-19 started to subside, we were hoping to see our business pick up, but the Taraval St. Project began construction, leaving many small merchants (including myself) on the verge of closing-up shop.

Before the project started, Sushi Zen Restaurant's monthly sales were ~\$90k, but since the construction, the sales have dropped down to \$70k. Therefore, we are projecting to lose over \$40k in sales for the months of January and February 2024.

The Taraval St. construction has deterred customers due to parking issues, road closures, constant jackhammering and demolition, and lack of business access. This leaves many customers to dine elsewhere as this is an inconvenience to them. **Taraval merchants need relief NOW, and are in need of the city to finish the project ASAP.**

I am writing to you all today to please approve the \$1 million re-appropriations request from APEC reserves for small business relief due to L Taraval St. construction project impacts.

I'm the co-owner and operator of Wine Down, a wine & beer bar located at 685 Folsom (between 3rd and Hawthorne), located directly in the highly restricted red security zone for the APEC Conference. Our business suffered significant financial loss during the week of APEC.

Typically, Moscone Center conferences like Dreamforce and RSA are a huge boost to our business but between the increased security, road closures, and overall discouragement for others outside of APEC conference attendees to travel to our area (resulting in several group event cancellations for us), we made the difficult to decision to close our business the week of APEC, as operating without customers would have forced us to suffer even greater financial loss.

We had submitted an application to get involved with APEC as an official event, but never received a response.

Our business is already suffering with our Yerba Buena/SOMA location so dependent on office workers returning to work, which hasn't happened; our revenue remains down more than 50% since 2019. Our closure during APEC week was another major blow.

We strongly support the creation of a relief fund for businesses and organizations impacted by APEC, and support increasing the amount for the fund to \$3 million so that all affected businesses and organizations can be adequately compensated.

Special thank you to Chair Chan for dedication to this issue and helping to make businesses in our community whole again.

Dear Budget Committee Members,

I am a co-owner of a cocktail bar called The Cordial, located at 163 Jessie Street. We were located inside the green zone during APEC.

Generally we try to survive the downturn in business since covid required we be closed. When we were able to open again, business has not rebounded for these reasons:

- 1) Street crime issues such as car break ins, retail theft, tagging, vandalism.
- 2) Drug addict street issues such as urinating and defecating in the area, passing out in or around our businesses and generally taking over of public space.
- 3) Layoffs and flexible schedules for office workers in the area.

Prior to APEC, some of the thinking was that it would have the same type of effect as a convention like Dreamforce a few weeks earlier. Businesses like ours depend on more and more conventions like Dreamforce and the Gamers convention to survive and thrive. When there are no conventions, we operate 3 days a week as that reflects the new work week offices are running in the area.

The prioritization of clearing the zone for security had a long-needed effect of forcing street crime, drug addicts out of the immediate area. Unfortunately, creating the security zone also rebuffed most of the would-be customers of our bar. The prospect that APEC attendees would stop in to our establishment never happened. We understand that many of the attendees had access to food and drinks and pre-arranged events which did not include our business.

It was great to see the sheer numbers of law enforcement, Homeland, SFPD, SF Sheriffs, CHP and more. It was good to know that we actually have law enforcement personnel in California and that they can be deployed to keep order and help us maintain a clean, cleared public environment.

Our neighborhood was afflicted with man-made problems, and the APEC security treatment was comparable to getting chemotherapy. A temporary force eradicated some of the sources crime, squalor and blight, but also killed the healthy business transaction in the area for the week.

I urge you to approve a \$3 million fund to support businesses which were affected.

My name is Michael Sopher. I am the managing member and owner of Tropisueño Mexican Restaurant on Yerba Buena Lane, between 3rd and 4th Streets, @ Mission and have been since opening in 2008. We are/were located within the secondary security zone for APEC and was very negatively impacted by this conference. I am sure you're going to hear the same story over and over again, and ours is exactly the same; we needed to pre-order product from our vendors because they refused to attempt the security zone for the week. Additionally, we had staffed according to The City and the press stating how this conference would bring a tremendous, much needed, financial lift to the area, which was fantastic news "post" COVID. My excitement for this convention was all for not. Our average sales before APEC was \$15-\$20,000 per day and for this convention, we did roughly \$3-\$6,000 per day. Add in the amount of wasted product and labor dollars, and our losses were substantial, upwards of \$100,000. Needless to say, when I heard that San Francisco would possibly help out those of us impacted by APEC, some of my excitement came back, until I saw it was only \$2,000,000. Based on what we lost alone, this amount most definitely needs to be increased to at the *very least*, \$3,000,000. Having lost two restaurants during COVID and almost losing Tropisueño, if it were not for the help of the federal government, my gratitude towards San Francisco, the state of California and of course "Uncle" Joe Biden for helping my family not lose absolutely everything is incalculable.

Lastly, I would like to thank all of you, especially Chair Chan for taking the time from your busy schedules to read my email and to take our issues with the APEC convention seriously. Many of our businesses are hanging on by a shoestring and APEC ended up being a dagger in the heart, so all of us are very grateful for your work on this.

Dear Budget & Finance Committee,

I am the owner of Rolling-Out Cafe at 1722 Taraval, and earnestly request that the \$1 million re-appropriations from APEC reserves to Taraval small businesses be granted. Many small businesses on Taraval, my store included, have been negatively affected by the ongoing L-Taraval MTA project on and near Taraval.

My store has been hurt by this L-Taraval project in multiple ways:

- (1) I have observed a significant drop in revenue since 3Q 2023 when access to my shop has been hindered the most and surrounding road conditions have been unpleasant to drivers. From 2Q 2023 to 3Q 2023, my store's revenue dropped by 34%. From 1st half 2023 (1Q+2Q) to 2nd half 2023 (3Q+4Q), revenue dropped by 37%. This trend of revenue drop is continuing. Customers have been saying to me that parking has been very difficult, and many times when they try to come to my shop, they would just give up because of the lack of parking. If the current revenue level continues, Rolling-Out may end up being another casualty from this L-Taraval project.
- (2) Up till 2023, I used to have 2 employees, both part time. I now have no employees. While I do hope to hire one, the current revenue makes it difficult.
- (3) In May 2022, I had to demolish our popular parklet to allow for the L-Taraval project. This parklet was a big part of our Parkside community. This parklet was made possible with the support from former Supervisors Carmen Chu and Katy Tang, a grant from the City, and money donated from many local residents and merchants. Customers have constantly asked me when the Parklet would come back as they are missing an outdoor seating area here to get together or to relax. There is simply no dollar value that can be put on the community's loss as a result of the demolition of this parklet.

The \$1 million requested by the current Supervisor Joel Engardio would help compensate for the losses experienced by many merchants on Taraval. I sincerely hope that you would grant this request.

In closing, while I am fully aware that the Budget Committee is not responsible for the current L-Taraval project, I do hope that the City and its departments involved would wrap up this L-Taraval project as soon as possible. All the people I've spoken to, residents and merchants alike, are very tired of the inconvenience this project has caused.

We are writing to express our strong support for the ordinance introduced by Supervisor Chan and co-sponsored by Supervisors Peskin and Dorsey, which proposes an appropriation of \$3 million as a relief fund for SOMA businesses impacted by the APEC event.

While we appreciate the willingness of the Mayor's office and the Office of Economic and Workforce Development (OEWD) to support \$2M for small businesses, we believe that the proposed amount does not fully address the losses suffered by businesses during APEC. Many businesses reported significant drops in foot traffic and sales, with some experiencing losses of up to 40%.

We understand that there are competing proposals for the remaining balance of the reserved funds. However, given the extent of the losses suffered by businesses during APEC, we believe it is crucial to allocate even a larger portion of funds to support the affected businesses.

We urge the committee to consider the real and substantial impact of the APEC perimeter on SoMA businesses and to allocate funds commensurate with the losses suffered. We thank you for your consideration.

There is a hearing today about the economic impact of the Taraval Project and as I am unable to attend the hearing, I am submitting this email. My name is Herbert Wong, OD, and my office is Parkside Optometry, located at 1816 Taraval Street. My office has been severely impacted by this project. Data from the 2021-2023, especially zeroing in on when the street around my office was haphazardly closed at random times. A clear indicator of the impact is on the total number of patients scheduled; as a sidenote, I did not have any changes in days off from 2021 to 2022 to 2023. From March 2021 to 2022 to 2023, my monthly patients schedule went from 50 to 65 to 36; April 2021 to 2022 to 2023, my monthly patients schedule went from 64 to 44 to 23; May 2021 to 2022 to 2023, my monthly patient schedule went from 66 to 62 to 57.

My name is Dennis Leary and I own the House of Shields and the Sentinel, which I have operated in hands-on fashion for the past 16 years.

APEC was a brutal experience for my staff and the bottom line - a security cordon was set up directly in front of the businesses on New Montgomery, which effectively quashed all foot traffic.

As you may know, APEC was only the latest body blow in a series of hits that began with COVID. My businesses suffered from vandalism, neglect, Landlord bankruptcy, and escalated costs over the past 3 years, and APEC only made the pain worse. During the week of APEC my revenues were down 30-50%.

My staff is on the older side (many have been with me for 10+ years), and have families to support. As for myself I welcomed a newborn in September.

And as hard as it was for my businesses, my neighbors fared much worse.

I would encourage you to walk down New Montgomery st sometime to see the devastation on the blocks - almost every ground floor space is vacant.

So with this in mind I support raising the revenue backfill to 3M, if that is possible.

Thank you to Chair Chan for your hard work on this matter. It will not be forgotten.

My name is Lisbeth Mardona, and I am writing from Benu restaurant, as one of the project managers there. While we were not able to attend yesterday's meeting at City Hall, we simply wanted to share our experience with the event.

As a restaurant located within a green security zone and just outside a red security zone, we definitely felt the effects of APEC that week. We had noticeably lower revenues, and for the guests who had initially decided to make reservations for that week, many opted to cancel as various information and updates regarding traffic control and restaurant access were being released. Operationally, many of our vendors were not able to reach us, including services for waste management. As a restaurant that works with a large number of various suppliers that deliver every day, the event brought these such challenges as well. In addition, our staff were also impacted in their commute to the restaurant, with some needing to spend additional hours getting to and from work.

Thank you Chair Chan for your attention to and work on this matter. We appreciate the opportunity to have our voice heard as well.

I trust this message finds you well. My name is Jenny St. Martin and I am one of the senior managers at The Cavalier restaurant located in downtown San Francisco at 360 Jessie Street off 5th, between Market Street and Mission Street.

I am reaching out to express our concerns regarding the impact of the APEC Summit on our business. The heightened security measures implemented in the vicinity of our business significantly reduced foot traffic and ultimately our sales making accessibility a challenge for our guests. Both visitors and locals were reluctant to navigate downtown due to increased traffic and security measures, and all of our previously booked clients canceled their private events. Ultimately, this resulted in a substantial decline in our sales with disastrous consequences to our P&L for this period. Typically, Q'4 brings holiday business and with it the ability to make up for slower times of the year. Sadly, the APEC Summit not only devastated our P&L for November, but our ability to stay profitable for the entire 2023 calendar year. While we were sold that the APEC Summit would drive significant business to the downtown areas, we experienced an unprecedented 40% deficit from our Q'4 annual budget when compared to 2022.

In light of these challenges, we at The Cavalier Restaurant wholeheartedly support the proposal to increase the APEC fund to 3 million dollars (\$). Such an adjustment would provide much-needed relief to businesses like ours that faced financial setbacks during what is traditionally a bustling time of the year.

We would also like to extend my personal gratitude to Chair Chan for her dedicated efforts on this important matter.

I hope this letter finds you well. My name is Michael Hsu, and I am the owner of Footprint, deeply rooted in the heart of our community in San Francisco's Sunset district. For over 25+ years, we have been proud to serve our neighborhood, offering the best selection of comfortable, mainstream shoes and apparel.

As you may be aware, the ongoing construction for the L Taraval Muni train, which commenced in 2022, has significantly impacted the daily operations and accessibility of local businesses, including ours. The prolonged nature of this construction has not only made it challenging for our customers to reach us but has also led to a noticeable decrease in foot traffic, critically affecting our sales. Specifically, our sales for November and December were down by 18% compared to the same period in 2022. This downturn has placed us in a precarious financial situation, further exacerbated by recent instances of burglaries and vandalism.

In light of these challenges, I am reaching out to solicit your support for the approval and implementation of a grant program designed to aid businesses adversely affected by this construction project. Dear Chair Chan, Supervisor Mandelman, and Supervisor Melgar,

We were unable to attend the meeting last Wednesday in regard to the significant impact that APEC had on our small business so I am writing this email to tell our specific story. Thank you in advance for taking the time to read this.

We are the owners of Café Madeleine at 149 New Montgomery Street (between Mission and Howard). As small business owners, we have experienced firsthand the disruptions and loss of income caused by this event.

Due to the high-profile attendees, security measures and road closures associated with APEC, it made it extremely difficult for customers and delivery drivers to access our business. As a bakery and café that does a large amount of catering to the Downtown area, it was also extremely difficult for us to make our own deliveries to customers, both wholesale and retail. The decreased foot traffic and disruptions to the area led to a sharp decline in sales overall during the summit period and the days leading up to it.

One of our main catering partners, Forkable, cancelled all orders for the whole week which amounts to about \$4000. We also lost most orders with other partners such as EZCater, DoorDash and Uber in addition to our own online ordering sales.

In addition to the loss of catering business discussed above, the sales in our café were down about 50% during the time Nov. 10-17th.

All in all, we would estimate a loss in sales of about \$20,000 - \$23,000 during the period of APEC.

We understand the importance of hosting international events but the needs of the local businesses and community were not taken into consideration. We had very little communication of how it was all going to be handled and it was extremely difficult for us. We were not even able to get our trash picked up.

We had already lost two of our three Café Madeleine locations due to the pandemic which is already devastating. We have spent the last 25 years building up our café, bakery and catering business so the loss of income from APEC was an additional hit to us.

We hope the legislation that would create a relief fund for businesses and organizations impacted by APEC is greatly considered for all the businesses that suffered financial losses during this time. We support increasing the amount of the fund to \$3 million.

It is essential that we work together to ensure that all businesses can thrive, even in the face of major events.

Thank you for your attention to this matter. It is greatly appreciated. We are grateful to Chair Chan for her work on this.
