2 AUTHORIZING RETROACTIVELY THE DISTRICT ATTORNEY OF THE CITY AND  
3 COUNTY OF SAN FRANCISCO TO APPLY FOR, ACCEPT, AND EXPEND FUNDS MADE  
4 AVAILABLE THROUGH THE CALIFORNIA DEPARTMENT OF INSURANCE (DOI) FOR A  
5 PROJECT ENTITLED "ORGANIZED AUTOMOBILE FRAUD ACTIVITY INTERDICTION  
6 ("URBAN GRANT") PROGRAM", AND INCLUDING INDIRECT COST NOT TO EXCEED  
7 5% OF GRANT-FUNDED PERSONNEL COSTS.

8 WHEREAS, The City and County of San Francisco desires to  
9 undertake a project designated the San Francisco District Attorney's  
10 Office Organized Automobile Fraud Activity Interdiction Program to  
11 be funded in part from funds made available through the California  
12 Department of Insurance (hereafter "DOI"); now, therefore, be it,

13 RESOLVED, That the District Attorney of the City and County of  
14 San Francisco is authorized retroactively to apply for, accept, and  
15 expend funds for organized automobile insurance fraud activity  
16 prosecution purposes from DOI, including indirect costs not to  
17 exceed the amount of 5% of grant-funded personnel costs; and, be it

18 FURTHER RESOLVED, That the District Attorney is authorized to  
19 execute on behalf of the City and County of San Francisco the  
20 necessary Grant Award Agreements for organized automobile fraud  
21 activity prosecution purposes including any extensions,  
22 augmentations, renewals or amendments thereof; and be it

23 AGREED, That there are no matching funds required for said  
24 project under the Organized Automobile Fraud Activity Interdiction

3 AGREED, That any liability arising out of the performance of  
4 the Grant Award Agreement, including civil court actions for  
5 damages, shall be the responsibility of the grant recipient and the

7 responsibility for any such liability, and, be it


8 FURTHER RESOLVED, That grant funds received hereunder shall not  
9 be used to supplant expenditures controlled by this body.




