9 WHEREAS, The San Francisco Public Utilities Commission (SFPUC) has taken a
10 leadership role in the resolution of issues surrounding Lake Merced and the Westside Basin
11 groundwater aquifer; and

12 WHEREAS, The SFPUC, the California Water Service Company and other users of the
13 Westside Basin have reached agreement on conducting a study to determine the feasibility of
14 using available storage space in the Westside Basin aquifer for the benefit of the SFPUC
15 water system, with corresponding benefits to management of Lake Merced water levels; and

16 WHEREAS, the SFPUC approved the proposed First Amendment to Water Supply
17 Contract with California Water Service Company in Resolution No. 02-0198 dated September
18 24, 2002; and

19 WHEREAS, The First Amendment to the Water Supply Contract Between the City and
20 County of San Francisco and the California Water Service Company for Purposes of
21 Conducting an Aquifer Recharge Study is on file with the Clerk of the Board of Supervisors in
22 File No. 021652, which is hereby declared to be a part of this resolution as if set
23 forth fully herein; and

1 WHEREAS, The contract amendment for conducting the aquifer recharge study is
2 categorically exempt under CEQA, State Guidelines, Section 15306, Class 6, Information
3 Collection; now therefore be it

4 RESOLVED, That the Board of Supervisors approves the terms and conditions
5 contained in the First Amendment to the Water Supply Contract Between the City and County
6 of San Francisco and the California Water Service Company for Purposes of Conducting an
7 Aquifer Recharge Study; and be it

8 FURTHER RESOLVED, that the Board of Supervisors authorizes the SFPUC General
9 Manager to sign the First Amendment to the Water Supply Contract Between the City and
10 County of San Francisco and the California Water Service Company for Purposes of
11 Conducting an Aquifer Recharge Study.
