**Ordinance amending the Park Code to allow the Recreation and Park Department to set fees for recreation programs based on the Department's operating costs for those programs and various other factors, including whether the program is designated for youth, seniors, or persons with disabilities, subject to approval of the Recreation and Park Commission; directing the Commission to update its scholarship policy to provide for further discounts for recreation programs based on financial need; making certain clarifying changes; and affirming the Planning Department's determination under the California Environmental Quality Act.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. Environmental Findings.

The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 250605 and is incorporated herein by reference. The Board affirms this determination.

Section 2. Article 12 of the Park Code is hereby amended by revising Section 12.01, revising and consolidating Sections 12.02 and 12.03 as Section 12.02; deleting Sections 12.15, 12.27, 12.29, 12.30, 12.39, and 12.48; and revising Sections 12.40, 12.44, and 12.45, to read as follows:

**SEC. 12.01. CAMP MATHER - OVERNIGHT GUESTS ~~CABIN AND TENT SITE~~  
~~USAGE FEES.~~**

(a) Fees for cabins and tent sites at Camp Mather, and meal fees for overnight guests, shall be set under Section 12.44. ~~The following use fees, which reflect a discount from the standard fee for nonresidential usage, shall be charged to San Francisco residents for use of cabin and tent sites at Camp Mather. The following fees do not include State occupancy tax.~~

#### **SEC. 12.44. RECREATION PROGRAM FEES.**

(a) Authorization to Impose Fees. The Department may set fees under this Section 12.44 for Recreation Programs it may offer to the public, unless otherwise specified in this Article 12, subject to the prior approval of the Recreation and Park Commission. The Department shall publish all approved fees on its website.

(b) Fees Based on Cost Recovery. The fee for each Recreation Program shall not exceed the estimated Operating Costs of that Program in the coming fiscal year, divided by the total number of slots that the Department will offer in the coming year for that Program; provided, however, that (1) the Department shall seek to recover not more than 75% of the estimated Operating Costs of Programs designated for youth or seniors or persons with disabilities, with the exception of Camp Mather, for which the fee may be based on 100% of the estimated Operating Costs; and (2) the Department shall give the highest priority to recovering not more than 50% of the costs of Programs where the Commission has found that a further reduction in the fee is necessary to provide benefits to the community at large.

(c) Scholarship Policy. The Commission shall review and update its March 2007 Scholarship Policy to provide discounts for Recreation Programs to qualifying San Francisco residents who are

any of the following: (1) members of a household with income equal to or less than 250% of the federal poverty level as determined by the United States Department Health and Human Services' Federal Poverty Guidelines, (2) youth in foster care, or (3) unhoused residents. This subsection (c) does not affect Camp Mather Low Income Fee Reductions as set forth in Park Code Section 12.04.

**(d) Definitions.**

"Recreation Program" means any class, activity, lesson, program, or similar service that the Department offers to the public.

"Operating Costs" shall consist of the cost to the Department to offer a Recreation Program, including staff time, expenses, and administrative costs, but shall not include costs related to any associated capital projects or deferred maintenance projects.

(a) A refund processing fee of \$10.00 or 20% percent of the fee, whichever is greater, will be charged when a person requests a refund of program fees.

(b) A program withdrawal fee of \$10.00 or 20% percent of the fee, whichever is greater, will be charged when a person withdraws from a program or activity.

(c) ~~There will be~~ Aa cancellation fee of \$20.00 or 20% percent of the rental fee, whichever is greater, for the cancellation of facility rental reservations.

(d) ~~There will be~~ Aa non-refundable application fee of \$50.00 for special event permits.

(e) ~~There will be~~ Aa \$25.00 fee when a reservation for use of an athletic field is rescheduled or canceled.

9           Section 3. Effective Date. This ordinance shall become effective 30 days after  
10 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
11 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
12 of Supervisors overrides the Mayor's veto of the ordinance.

13  
14           Section 4. Scope of Ordinance.

15           (a) In enacting this ordinance, the Board of Supervisors intends to amend only  
16 those words, phrases, paragraphs, subsections, sections, articles, numbers, punctuation  
17 marks, charts, diagrams, or any other constituent parts of the Municipal Code that are  
18 explicitly shown in this ordinance as additions, deletions, Board amendment additions, and  
19 Board amendment deletions in accordance with the "Note" that appears under the official title  
20 of the ordinance.

21           (b) The various codified fees presented as existing Code text in Section 2 of this  
22 ordinance do not necessarily reflect the fees that are currently applicable. Pursuant to Park  
23 Code Section 12.20, the Controller adjusts those fees on an annual basis to reflect changes in  
24 the Consumer Price Index. This ordinance is not intended to invalidate any adjustments under  
25 Section 12.20 that the Controller has previously approved.

1 (c) The current fees (including any Controller adjustments to those fees) 20 shall  
2 continue to apply, until a cost recovery fee is set with approval of the Recreation and Park  
3 Commission under the proposed Section 12.44. Further, the deletion of sections of the Park  
4 Code referencing specific program fees in Section 2 of this ordinance does not mean that the  
5 Department is prohibited from charging a fee for those programs. The intent of this ordinance  
6 is to allow the Department to set fees for those programs under the proposed Section 12.44  
7 instead.

8  
9 Section 5. Severability.

10 If any section, subsection, sentence, clause, phrase, or word of this ordinance, or any  
11 application thereof to any person or circumstance, is held to be invalid or unconstitutional by a  
12 decision of a court of competent jurisdiction, such decision shall not affect the validity of the  
13 remaining portions or applications of the ordinance. The Board of Supervisors hereby  
14 declares that it would have passed this ordinance and each and every section, subsection,  
15 sentence, clause, phrase, and word not declared invalid or unconstitutional without regard to  
16 whether any other portion of this ordinance or application thereof would be subsequently  
17 declared invalid or unconstitutional.

## **LEGISLATIVE DIGEST**

[Park Code - Recreation Program Fees]

**Ordinance amending the Park Code to allow the Recreation and Park Department to set fees for recreation programs based on the Department's operating costs for those programs and various other factors, including whether the program is designated for youth, seniors, or persons with disabilities, subject to approval of the Recreation and Park Commission; directing the Commission to update its scholarship policy to provide for further discounts for recreation programs based on financial need; making certain clarifying changes; and affirming the Planning Department's determination under the California Environmental Quality Act.**

### **Existing Law**

The Park Code sets fees for various recreation programs offered by the Recreation and Park Department.

### **Amendments to Current Law**

The proposed ordinance would allow the Recreation and Park Department to set recreation program fees based on the estimated operating costs of those programs. The Department generally could set fees intended to cover the programs' full operating costs, but for programs designated for youth or seniors or persons with disabilities could set fees that recovered only 75% of the operating costs. In addition, the ordinance urges the Department to set fees for programs that benefit the community at large based on only 50% of the operating costs. All fees would require approval from the Recreation and Park Commission and once approved would be published on the Department's website.

The ordinance also directs the Recreation and Park Commission to update its scholarship policy to provide for further discounts for recreation programs based on financial need.

### **Background Information**

The current recreation program fees would continue to apply pending the Department setting new fees based on cost recovery under the proposed ordinance.



San Francisco Business and Tax Regulations, Section 249.6, will establish an annual fee of \$229 per hour for each refuse collector licensed by the Director of Health for each refuse collection route permitted by the Director of Health in accordance with the Health Code, Section 22A.19, will be modified to increase the initial fee payable to the Department of Public Health upon filing documents for review in administration of the Health Code, Section 22A.19, from \$609.50 to \$1,000, and increase the additional fee from \$203.17 to \$333 per hour exceeding three hours or portion thereof. 
