AUTHORIZING THE CHIEF OF POLICE OF THE CITY AND COUNTY OF SAN FRANCISCO TO ACCEPT AND EXPEND FUNDS MADE AVAILABLE THROUGH THE OFFICE OF CRIMINAL JUSTICE PLANNING FOR A PROJECT ENTITLED “VIOLENCE AGAINST WOMEN – LAW ENFORCEMENT SPECIALIZED UNITS PROGRAM,” AND AGREEING TO ACCEPT AN IN-KIND MATCH FROM WOMAN ORGANIZED TO MAKE ABUSE NON-EXISTENT (W.O.M.A.N. Inc.) FOR A VICTIM’S ADVOCATE POSITION, AND WAIVING INDIRECT COSTS DUE TO FUNDING CONSTRAINTS.

WHEREAS, the Chief of Police of the City and County of San Francisco desires to undertake a certain project designated “Violence Against Women – Law Enforcement Specialized Units Program” (herin after referred to as “VAWLESUP”) to be funded in part from funds made available through the California Office of Criminal Justice Planning (“OCJP”); for the reduction of repeat domestic violence against women; and

WHEREAS, W.O.M.A.N. Inc. agrees to provide an in-kind match to fund a Victim’s Advocate position. This Victim’s Advocate will partner with the Domestic Violence Inspector to deliver services to women who have been victims of repeated domestic violence; now therefore be it







