4 **City and County of San Francisco for \$110,000; the lawsuit was filed on January 25,**
5 **2023, in San Francisco Superior Court, Case No. CGC-23-604225; entitled Marvella**
6 **Branner v. City and County of San Francisco; the lawsuit involves an alleged personal**
7 **injury on a City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
11 authorizes the City Attorney to settle the action entitled Marvella Branner v. City and County of
12 San Francisco, San Francisco Superior Court, Case No. CGC-23-604225 by the payment of
13 \$110,000. The lawsuit involves an alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 25, 2023, and the following parties were named in the lawsuit: Plaintiff: Marvella
16 Branner; Defendant: City and County of San Francisco.
