2 ENACTING AND RESCINDING PARKING REGULATIONS AT VARIOUS LOCATIONS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
4 and the San Francisco Traffic Code, the following regulations governing the parking of  
5 vehicles are hereby enacted or rescinded as designated below:

6 **NO PARKING ANYTIME - RESCIND**

7 Dore Street, west side, between Bryant and Brannan Streets

8 **ONE-HOUR PARKING TIME LIMIT, 7 AM - 6 PM, MONDAY THROUGH SATURDAY -  
RESCIND**

9 **PARKING METER AREA NO. 3 (1-HOUR PARKING TIME LIMIT, 7 AM - 6 PM, MONDAY  
THROUGH SATURDAY) - ESTABLISH**

10 Ellis Street, north side, from 97 feet to 218 feet west of Van Ness Avenue (121-foot  
11 zone, extending existing parking meter area)

12 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 6 PM,  
MONDAY THROUGH FRIDAY) - ESTABLISH**

13 Judah Street, both sides, between 7th and 8th Streets (200 block)

14 **RESIDENTIAL PERMIT PARKING AREA "O" (2-HOUR TIME LIMIT, 8 AM - 6 PM,  
15 MONDAY THROUGH FRIDAY) - ESTABLISH**

16 San Fernando Way, both sides, between Darien Way and Monterey Boulevard  
17 (200 block)

18 San Leandro Way, both sides, between Darien Way and Monterey Boulevard (200  
block)

19 **TWO-HOUR PARKING TIME LIMIT, 8 AM - 5 PM, MONDAY THROUGH SATURDAY -  
20 ESTABLISH**




