3 **Ordinance amending the San Francisco Planning Code Sections 102.9, 155.1, 155.4,**
4 **and 228 et. seq. to: 1) expand the applicability of bicycle parking requirements; 2)**
5 **exempt bicycle parking from Floor-Area ratio calculations; 3) permit the conversion of**
6 **Automotive Service Stations located on Primary Transit Streets and Citywide**
7 **Pedestrian Network Streets to another use without Conditional Use authorization; and**
8 **4) adopting environmental findings, Section 302 findings, and findings of consistency**
9 **with the General Plan and the Priority Policies of Planning Code Section 101.1.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Findings.

16 (a) The Planning Department has determined that the actions contemplated in this
17 ordinance comply with the California Environmental Quality Act (California Public Resources
18 Code Section 21000 et seq.). Said determination is on file with the Clerk of the Board of
19 Supervisors in File No. 120471 and is incorporated herein by reference.

20 (b) Pursuant to Planning Code Section 302, this Board finds that these Planning Code
21 amendments will serve the public necessity, convenience, and welfare for the reasons set
22 forth in Planning Commission Resolution No. 18553 and the Board incorporates such reasons
23 herein by reference. A copy of Planning Commission Resolution No. 18553 is on file with the
24 Clerk of the Board of Supervisors in File No. 110548.

1 (c) This Board finds that these Planning Code amendments are consistent with the
2 General Plan and with the Priority Policies of Planning Code Section 101.1 for the reasons set
3 forth in Planning Commission Resolution No. 18553, and the Board hereby incorporates such
4 reasons herein by reference.

5
6 Section 2. The San Francisco Planning Code is hereby amended by amending
7 Sections 102.9, 155.1, 155.4, and 228 et seq., to read as follows:

8 **SEC. 102.9. FLOOR AREA, GROSS.**

9 In districts other than C-3, the sum of the gross areas of the several floors of a building
10 or buildings, measured from the exterior faces of exterior walls or from the centerlines of walls
11 separating two buildings. Where columns are outside and separated from an exterior wall
12 (curtain wall) which encloses the building space or are otherwise so arranged that the curtain
13 wall is clearly separate from the structural members, the exterior face of the curtain wall shall
14 be the line of measurement, and the area of the columns themselves at each floor shall also
15 be counted.

16 In C-3 Districts and the Van Ness Special Use District, the sum of the gross areas of
17 the several floors of a building or buildings, measured along the glass line at windows at a
18 height of four feet above the finished floor and along a projected straight line parallel to the
19 overall building wall plane connecting the ends of individual windows; provided, however, that
20 such line shall not be inward of the interior face of the wall.

21 (a) Except as specifically excluded in this definition, "gross floor area" shall include,
22 although not be limited to, the following:

23 (1) Basement and cellar space, including tenants' storage areas and all other space
24 except that used only for storage or services necessary to the operation or maintenance of the
25 building itself;

1 (2) Elevator shafts, stairwells, exit enclosures and smokeproof enclosures, at each
2 floor.

3 (3) Floor space in penthouses except as specifically excluded in this definition;

4 (4) Attic space (whether or not a floor has been laid) capable of being made into
5 habitable space;

6 (5) Floor space in balconies or mezzanines in the interior of the building;

7 (6) Floor space in open or roofed porches, arcades or exterior balconies, if such porch,
8 arcade or balcony is located above the ground floor or first floor of occupancy above
9 basement or garage and is used as the primary access to the interior space it serves;

10 (7) Floor space in accessory buildings, except for floor spaces used for accessory off-
11 street parking or loading spaces as described in Section 204.5 of this Code, and driveways
12 and maneuvering areas incidental thereto; and

13 (8) Any other floor space not specifically excluded in this definition.

14 (b) "Gross floor area" shall not include the following:

15 (1) Basement and cellar space used only for storage or services necessary to the
16 operation or maintenance of the building itself;

17 (2) Attic space not capable of being made into habitable space;

18 (3) Elevator or stair penthouses, accessory water tanks or cooling towers, and other
19 mechanical equipment, appurtenances and areas necessary to the operation or maintenance
20 of the building itself, if located at the top of the building or separated therefrom only by other
21 space not included in the gross floor area;

22 (4) Mechanical equipment, appurtenances and areas, necessary to the operation or
23 maintenance of the building itself (i) if located at an intermediate story of the building and
24 forming a complete floor level; or (ii) in C-3 Districts, if located on a number of intermediate
25 stories occupying less than a full floor level, provided that the mechanical equipment,

1 appurtenances and areas are permanently separated from occupied floor areas and in
2 aggregate area do not exceed the area of an average floor as determined by the Zoning
3 Administrator;

4 (5) Outside stairs to the first floor of occupancy at the face of the building which the
5 stairs serve, or fire escapes;

6 (6) Floor space used for accessory off-street parking and loading spaces as described
7 in Section 204.5 of this Code and up to a maximum of one hundred fifty percent (150%) of the
8 off-street accessory parking permitted by right in Section 151.1 of this Code for C-3 Districts,
9 and driveways and maneuvering areas incidental thereto;

10 (7) Bicycle parking which meets the standards of Sections 155.1 through 155.5 of this Code.

11 (8) Arcades, plazas, walkways, porches, breezeways, porticos and similar features
12 (whether roofed or not), at or near street level, accessible to the general public and not
13 substantially enclosed by exterior walls; and accessways to public transit lines, if open for use
14 by the general public; all exclusive of areas devoted to sales, service, display, and other
15 activities other than movement of persons;

16 ~~(8)~~ (9) Balconies, porches, roof decks, terraces, courts and similar features, except
17 those used for primary access as described in Paragraph (a)(6) above, provided that:

18 (A) If more than 70 percent of the perimeter of such an area is enclosed, either by
19 building walls (exclusive of a railing or parapet not more than three feet eight inches high) or
20 by such walls and interior lot lines, and the clear space is less than 15 feet in either
21 dimension, the area shall not be excluded from gross floor area unless it is fully open to the
22 sky (except for roof eaves, cornices or belt courses which project not more than two feet from
23 the face of the building wall).

24 (B) If more than 70 percent of the perimeter of such an area is enclosed, either by
25 building walls (exclusive of a railing or parapet not more than three feet eight inches high), or

1 by such walls and interior lot lines, and the clear space is 15 feet or more in both dimensions,
2 (1) the area shall be excluded from gross floor area if it is fully open to the sky (except for roof
3 eaves, cornices or belt courses which project no more than two feet from the face of the
4 building wall), and (2) the area may have roofed areas along its perimeter which are also
5 excluded from gross floor area if the minimum clear open space between any such roof and
6 the opposite wall or roof (whichever is closer) is maintained at 15 feet (with the above
7 exceptions) and the roofed area does not exceed 10 feet in depth; (3) in addition, when the
8 clear open area exceeds 625 square feet, a canopy, gazebo, or similar roofed structure
9 without walls may cover up to 10 percent of such open space without being counted as gross
10 floor area.

11 (C) If, however, 70 percent or less of the perimeter of such an area is enclosed by
12 building walls (exclusive of a railing or parapet not more than three feet eight inches high) or
13 by such walls and interior lot lines, and the open side or sides face on a yard, street or court
14 whose dimensions satisfy the requirements of this Code and all other applicable codes for
15 instances in which required windows face upon such yard, street or court, the area may be
16 roofed to the extent permitted by such codes in instances in which required windows are
17 involved;

18 ~~(9)~~ (10) On lower, nonresidential floors, elevator shafts and other life-support systems
19 serving exclusively the residential uses on the upper floors of a building;

20 ~~(10)~~ (11) One-third of that portion of a window bay conforming to the requirements of
21 Section 136(d)(2) which extends beyond the plane formed by the face of the facade on either
22 side of the bay but not to exceed seven square feet per bay window as measured at each
23 floor;

24 ~~(11)~~ (12) Ground floor area in the C-3-0, C-3-O(SD), C-3-S, C-3-S(SU) and C-3-G
25 Districts devoted to building or pedestrian circulation and building service;

1 ~~(12)~~ (13) In the C-3-0, C-3-O(SD), C-3-S, C-3-S(SU) and C-3-G Districts, space
2 devoted to personal services, restaurants, and retail sales of goods intended to meet the
3 convenience shopping and service needs of downtown workers and residents, not to exceed
4 5,000 occupied square feet per use and, in total, not to exceed 75 percent of the area of the
5 ground floor of the building plus the ground level, on-site open space. Said uses shall be
6 located on the ground floor, except that, in order to facilitate the creation of more spacious
7 ground floor interior spaces, a portion of the said uses, in an amount to be determined
8 pursuant to the provisions of Section 309, may be located on a mezzanine level;

9 ~~(13)~~ (14) An interior space provided as an open space feature in accordance with the
10 requirements of Section 138

11 ~~(14)~~ (15) Floor area in C-3, South of Market Mixed Use Districts, and Eastern
12 Neighborhoods Mixed Use Districts devoted to child care facilities provided that:

13 (A) Allowable indoor space is no less than 3,000 square feet and no more than 6,000
14 square feet, and

15 (B) The facilities are made available rent free, and

16 (C) Adequate outdoor space is provided adjacent, or easily accessible, to the facility.

17 Spaces such as atriums, rooftops or public parks may be used if they meet licensing
18 requirements for child care facilities, and

19 (D) The space is used for child care for the life of the building as long as there is a
20 demonstrated need. No change in use shall occur without a finding by the City Planning
21 Commission that there is a lack of need for child care and that the space will be used for a
22 facility described in Subsection 15 below dealing with cultural, educational, recreational,
23 religious, or social service facilities;

24 ~~(15)~~ (16) Floor area in C-3, South of Market Mixed Use Districts, and Eastern
25 Neighborhoods Mixed Use Districts permanently devoted to cultural, educational, recreational,

1 religious or social service facilities available to the general public at no cost or at a fee
2 covering actual operating expenses, provided that such facilities are:

3 (A) Owned and operated by a nonprofit corporation or institution, or

4 (B) Are made available rent free for occupancy only by nonprofit corporations or
5 institutions for such functions. Building area subject to this subsection shall be counted as
6 occupied floor area, except as provided in Subsections 102.10(a) through (f) of this Code, for
7 the purpose of calculating the off-street parking and freight loading requirements for the
8 project;

9 ~~(16) In C-3 Districts, floor space used for short term parking and aisles incidental thereto when
10 required pursuant to Section 309 in order to replace short term parking spaces displaced by the
11 building or buildings;~~

12 (17) Floor space in mezzanine areas within live/work units where the mezzanine
13 satisfies all applicable requirements of the San Francisco Building Code;

14 (18) Floor space suitable primarily for and devoted exclusively to exhibitions or
15 performances by live/work tenants within the structure or lot, provided that such facilities will
16 be available rent-free to live/work tenants within the property for the life of the structure; and

17 (19) In South of Market Mixed Use Districts, live/work units and any occupied floor
18 area devoted to mechanical equipment or appurtenances or other floor area accessory to
19 live/work use provided that:

20 (A) The nonresidential use within each live/work unit shall be limited to uses which are
21 principal permitted uses in the district or otherwise are conditional uses in the district and are
22 approved as a conditional use,

23 (B) The density, enforcement, open space, parking and freight loading and other
24 standards specified in Sections 124(j), 135.2, 151 and 152.1 shall be satisfied, along with all
25 other applicable provisions of this Code, and

1 (C) For the purpose of calculating the off-street parking and freight loading
2 requirement for the project, building area subject to this subsection shall be counted as
3 occupied floor area, except as provided in Subsections 102.10(a) through (f) of this Code.

4 **SEC. 155.1. BICYCLE PARKING REQUIREMENTS FOR CITY-OWNED AND LEASED**
5 **BUILDINGS.**

6 In all City-owned and leased buildings, regardless of whether off-street parking is
7 available, the responsible City official, as defined in Section 155.1(a)(11) below, shall provide
8 bicycle parking according to the schedule in Section 155.1(c) below, except as otherwise
9 provided in Section 155.2. The provisions of this Section shall not apply in any case where the
10 City occupies property as a tenant under a lease the term of which does not exceed six
11 months. In the event that a privately owned garage, as defined in Section 155.2, is in a
12 building in which the City leases space, Section 155.2 and not this Section shall apply. All
13 required bicycle parking shall conform to the requirements of Sections 155.1(b) (Location of
14 Facilities) and 155.1(c) (Number of Spaces) set forth below:

15 (a) **Definitions.**

16 (1) **Locker.** A fully enclosed, secure and burglar-proof bicycle parking space
17 accessible only to the owner or operator of the bicycle.

18 (2) **Check-in Facility.** A location in which the bicycle is delivered to and left with an
19 attendant with provisions for identifying the bicycle's owner. The stored bicycle is accessible
20 only to the attendant.

21 (3) **Monitored Parking.** A location where Class 2 parking spaces are provided within
22 an area under constant surveillance by an attendant or security guard or by a monitored
23 camera.

1 (4) **Restricted Access Parking.** A location that provides Class 2 parking spaces
2 within a locked room or locked enclosure accessible only to the owners of bicycles parked
3 within.

4 (5) **Personal Storage.** Storage within the view of the bicycle owner in either the
5 operator's office or a location within the building.

6 (6) **Class 1 Bicycle Parking Space(s).** Facilities which protect the entire bicycle, its
7 components and accessories against theft and against inclement weather, including wind-
8 driven rain. Examples of this type of facility include (1) lockers, (2) check-in facilities, (3)
9 monitored parking, (4) restricted access parking, and (5) personal storage.

10 (7) **Class 2 Bicycle Parking Space(s).** Bicycle racks which permit the locking of the
11 bicycle frame and one wheel to the rack and, which support the bicycle in a stable position
12 without damage to wheels, frame or components.

13 (8) **Director.** Director of ~~the Department of City~~ Planning.

14 (9) **Landlord.** Any person who leases space in a building to the City. The term
15 "landlord" does not include the City.

16 (10) **Employees.** Individuals employed by the City and County of San Francisco.

17 (11) **Responsible City Official.** The highest ranking City official of an agency or
18 department which has authority over a City-owned building or parking facility or of an agency
19 or department for which the City is leasing space.

20 (12) **Person.** Any individual, proprietorship, partnership, joint venture, corporation,
21 limited liability company, trust, association, or other entity that may enter into leases.

22 (b) **Location of Facilities.**

23 (1) **Majority of Spaces Are Long-Term.** At locations where the majority of parking
24 spaces will be long-term (e.g., occupied by building employees for eight hours or more), at
25 least ½ of the required bicycle parking spaces shall be Class 1 spaces. The remaining spaces

1 may be Class 2 spaces. The Director may approve alternative types of parking spaces that
2 provide an equivalent measure of security.

3 (2) **Alternative Locations.** In the event that compliance with Section 155.1(b)91) may
4 not be feasible because of demonstrable hardship, the responsible city official may apply to
5 the Director for approval of an alternative storage location. In acting upon such applications,
6 the Director shall be guided by the following criteria: Such alternative facilities shall be well-
7 lighted and secure. The entrance shall be no more than 50 feet from the entrance of the
8 building, unless there are no feasible locations within a 50 foot zone that can be provided
9 without impeding sidewalk or pedestrian traffic. However, in no event shall an alternative
10 location be approved that is farther from the entrance of the building than the closest
11 automobile parking space.

12 (3) **Exemptions.** If no feasible alternative parking facility exists nearby which can be
13 approved pursuant to Section 155.1(b)(1) or (2), no Class 1 bicycle parking is provided in the
14 building, or, securing an alternative location would be unduly costly and pose a demonstrable
15 hardship on the landlord, or on the City, where the City owns the building, the Director may
16 issue an exemption. In order to obtain an exemption, the responsible City official shall certify
17 to the Director in writing that the landlord, or the City, where the City owns the building, will not
18 prohibit bicycle operators from storing bicycles within their office space, provided that they are
19 stored in such a way that the Fire Code is not violated and that the normal business of the
20 building is not disrupted.

21 (c) **Required Number of Bicycle Parking Spaces.**

22 (1) **Class 1 Bicycle Parking Spaces.** The following standards shall govern the
23 number of Class 1, long-term, bicycle parking spaces a responsible City official must provide:

24 (A) In buildings with one to 20 employees, at least two bicycle parking spaces shall be
25 provided.

1 (B) In buildings with 21 to 50 employees, at least four bicycle parking spaces shall be
2 provided.

3 (C) In buildings with 51 to 300 employees, the number of bicycle parking spaces
4 provided shall be equal to at least five percent of the number of employees at that building,
5 but in no event shall fewer than five bicycle spaces be provided.

6 (D) In buildings with more than 300 employees, the number of bicycle parking spaces
7 provided shall be equal to at least three percent of the number of employees at that building
8 but in no event shall fewer than 16 bicycle parking spaces be provided.

9 (2) Class 2 Bicycle Parking Spaces. In addition to the Class 1 bicycle parking spaces
10 required above, a responsible City official shall also provide Class 2 bicycle parking spaces
11 according to the below enumerated schedule:

12 (A) In buildings with one to 40 employees, at least two bicycle parking spaces shall be
13 provided.

14 (B) In buildings with 41 to 50 employees, at least four bicycle parking spaces shall be
15 provided.

16 (C) In buildings with 51 to 100 employees, at least six bicycle parking spaces shall be
17 provided.

18 (D) In buildings with more than 100 employees, at least eight bicycle parking spaces
19 shall be provided. Wherever a responsible City official is required to provide eight or more
20 Class 2 bicycle parking spaces, at least 50 percent of those parking spaces shall be covered.

21 (3) Public Buildings. In public buildings where the City provides a public service to
22 members of the public who are patrons or users of the buildings, such as libraries, museums,
23 and sports facilities, the responsible City official shall provide the number of bicycle parking
24 spaces as set out in Section 155.1(c)(1) and (2), except that the average patron load in a
25 building during peak use hours as determined by the Director, rather than the number of

1 employees, shall determine the number of spaces required. This Section shall not apply
2 where a public building has a "garage" (as such term is defined in Section 155.2(a)) that is
3 open to the general public, in which case Section 155.2 shall apply.

4 (4) **Annual Survey.** The Director shall annually survey the amount, location, and usage
5 of provided bicycle parking spaces in all buildings subject to the requirements of this Section
6 in order to ascertain whether current requirements are adequate to meet demand for such
7 parking spaces. If current requirements are inadequate, the Director shall draft and submit to
8 the Board of Supervisors proposed legislation that would remedy the deficiency.

9 (5) **Reductions.** The Director may grant a reduction from the number of bicycle
10 parking spaces required by this Section where the applicant shows based upon the type of
11 patronage, clientele, or employees using the building that there is no reason to expect a
12 sufficient number of bicycle-riding patrons, clientele or employees to justify the number of
13 spaces otherwise required by the Section.

14 (d) **Layout of Spaces.** Class 1 and Class 2 bicycle parking spaces or alternative
15 spaces approved by the Director shall be laid out according to the following:

16 (1) An aisle or other space to enter and leave the facility shall be provided. The aisle
17 shall provide a width of five feet to the front or rear of a standard six-foot bicycle parked in the
18 facility.

19 (2) Each bicycle parking space shall provide an area at least two feet wide by six feet
20 deep. Vertical clearance shall be at least 78 inches.

21 (3) Bicycle parking shall be at least as conveniently located as the most convenient
22 nondisabled car parking. Safe and convenient means of ingress and egress to bicycle parking
23 facilities shall be provided. Safe and convenient means include, but are not limited to
24 stairways, elevators and escalators.

25

1 (4) Bicycle parking and automobile parking shall be separated by a physical barrier or
2 sufficient distance to protect parking bicycles from damage. The number of required
3 automobile parking spaces may be lowered in buildings where Class 1 bicycle parking is
4 provided. The number of otherwise required automobile parking spaces may be reduced,
5 commensurate with the space necessary to provide Class 1 or Class 2 bicycle parking
6 spaces, in an amount that meets or exceeds the requirements of this section. This provision
7 only applies to the explicit area used for Class 1 or Class 2 bicycle parking.

8 (5) Class 2 bicycle racks shall be located in highly visible areas to minimize theft and
9 vandalism.

10 (6) Where Class 2 bicycle parking areas are not clearly visible to approaching
11 bicyclists, signs shall indicate the locations of the facilities.

12 (7) The surface of bicycle parking spaces need not be paved, but shall be finished to
13 avoid mud and dust.

14 (8) All bicycle racks and lockers shall be securely anchored to the ground or building
15 structure.

16 (9) Bicycle parking spaces may not interfere with pedestrian circulation.

17 (e) **Lease Provisions.**

18 (1) All City leases of buildings that are subject to the requirements of this Section and
19 under which the City is a tenant shall specifically provide that the landlord agrees to make
20 space available in the building for the term of the lease within which the responsible City
21 official may install, at no cost to the landlord, bicycle parking facilities that are in compliance
22 with this Section.

23 (2) This Subsection (e) does not in any way limit the ability of the Director to approve
24 alternative storage locations under Subsection (b)(2) or exemptions under Subsection (b)(3).
25 In the event that an exemption is granted or an alternative location is approved allowing the

1 installation of bicycle parking facilities on property that is not included (i) in a building leased
2 by the responsible city official or (ii) on property that belongs to the landlord, Subsection (e)(1)
3 does not apply. If the alternative location is on property that is owned by the landlord, but is
4 not inside the building to be leased by the responsible city official, the lease provision of
5 Subsection (e)(1) is required and shall identify that property as the location of the bicycle
6 parking spaces.

7 ~~(f) **Enforcement.** Article 1.5, Section 151.1 shall be enforced by the Zoning Administrator.~~
8 ~~Upon complaint, the Zoning Administrator shall investigate. If the Zoning Administrator concludes that~~
9 ~~a violation exists, he or she shall provide written notice to the responsible City official offering thirty~~
10 ~~days to cure the violation. The written notice shall inform the responsible City official of the grounds~~
11 ~~for the Zoning Administrator's conclusion that this Section has been violated. The notice shall afford~~
12 ~~the responsible City official an opportunity to meet with the Zoning Administrator to explain why~~
13 ~~penalties should not be assessed. The Zoning Administrator shall assess penalties upon the responsible~~
14 ~~City official's agency or department according to the following provisions:~~

15 ~~(1) If the responsible City official's violation has not been cured within the 30 days, a penalty of~~
16 ~~\$50/day shall be assessed by the Zoning Administrator, commencing with the first date of the violation.~~

17 ~~(2) All fines collected for violations of this Section shall be deposited with the Department of~~
18 ~~Parking and Traffic for expenditure by and for the Department's Bicycle Program.~~

19 ~~(f) (g) **Miscellaneous Requirements.**~~

20 (1) The responsible City official shall not, and shall encourage landlords not to,
21 establish or enforce any building policy that restricts or discourages building tenants,
22 employees, or visitors from utilizing their bicycle storage spaces.

23 (2) In any building that contains more than the required number of bicycle parking
24 spaces as set forth in Article 1.5, Section 155.1, the responsible City official shall not remove
25 such additional bicycle parking spaces without petitioning the Director. Such a petition may

1 not be filed until at least one year has elapsed following the effective date of this Section. That
2 petition shall demonstrate that the spaces the responsible City official seeks authority to
3 remove have not been necessary to meet the demand of employees and other building users.

4 (3) The responsible City official shall be responsible for full compliance with this
5 Section. The Board of Supervisors does not intend to impose requirements of this Section on
6 any responsible City official where such application would impair obligations of contract.

7 (4) Buildings with existing traditional-type racks which support only one wheel shall



LEGISLATIVE DIGEST

[Planning Code - Bicycle Parking; Automotive Service Station Conversions]

Ordinance amending the San Francisco Planning Code Sections 102.9, 155.1, 155.4, and 228 et. seq. to: 1) expand the applicability of bicycle parking requirements; 2) exempt bicycle parking from Floor-Area ratio calculations; 3) permit the conversion of Automotive Service Stations located on Primary Transit Streets and Citywide Pedestrian Network Streets to another use without Conditional Use authorization; and 4) adopting environmental findings, Section 302 findings, and findings of consistency with the General Plan and the Priority Policies of Planning Code Section 101.1

Existing Law

Section 102.9 of the Planning Code defines gross floor area ratio (FAR) as a ratio of a building's floor area to the area of the lot, and specifies the building uses and features that are included or are exempt from FAR calculations. Space dedicated to bicycle parking counts towards building gross FAR. Section 102.9 also exempts replacement parking in Downtown Commercial (C-3) districts from gross floor area ratio if the replacement parking is required under Section 309. Section 309 was amended by a prior ordinance to no longer require replacement parking.

Section 155.1 sets forth the bicycle parking requirements of City-owned and leased buildings. It tasks the Zoning Administrator with enforcing Bicycle Parking requirements, and specifies is a \$50/day fine imposed on violations if they have not been abated within 30 days. Fines are deposited with the Department of Parking and Traffic for expenditure by and for the Department's Bicycle Program. It also provides that General Fund revenues be used to pay for the purchase or installation of bicycle storage facilities.

Section 155.4 requires secure bicycle parking in newly constructed commercial buildings, and in enlarged commercial buildings that have a construction cost of at least \$1,000,000.00. Hotels are exempted from bicycle parking requirements.

Sections 228 et seq. require conditional use authorization to convert an Automobile Service Station to another use, and establish criteria for consideration by the Planning Commission when deliberating a conditional use application for such conversions.

Amendments to Current Law

Section 102.9 is amended to exempt Bicycle parking from gross FAR calculations, and to remove the obsolete reference to exemptions for replacement parking.

Section 155.1 is amended so that enforcement of bicycle parking requirements will be handled through the regular Planning Department enforcement procedures, and fees for violating this section of the Code will, like other enforcement fees, remain with the Planning Department to support code enforcement. It deletes the provision for use of General Fund revenues for the purchase and installation of bicycle storage facilities.

Section 155.4 is amended to require bicycle parking when a building undergoes a major change of use, involving half or more of the building's square footage, or 10,000 or more square feet. Bicycle parking will also be required for any increase in the amount of off-street automobile parking. Bicycle parking will be required for hotel uses in the same manner as for retail uses.

Sections 228 et seq. are consolidated into a single section, and amended to permit automobile service stations on transit-priority and major pedestrian streets to be converted to another use without conditional use authorization. The conditional use criteria for conversion are amended to include consideration of transportation impacts of the existing and proposed use.

Background

San Francisco has adopted a goal of having 20% of trips by bicycle by 2012. The purpose of this ordinance is to help achieve that goal by ensuring that bike commuters have a safe and secure place to park their bikes when they get to work. The ordinance expands applicability of bicycle parking requirements to more projects and to additional uses. It also provides incentives for both voluntary compliance and for exceeding minimum bicycle parking requirements by removing bicycle parking from FAR calculations, thereby removing a perceived "penalty" for including bike parking in a development and creating an incentive to dedicate more space to bike parking than required.

The ordinance also seeks to improve enforcement of bicycle parking requirements by treating bicycle parking violations like any other Planning Code violation, and keeping the fees generated from enforcement with the Planning Department to cover costs associated with that enforcement.

The revisions to the Planning Code's provisions for conversion of Automotive Service Stations seek to balance the desire to retain these uses with City policies which support walking, cycling, and public transportation, and which encourage new jobs and housing to be located in transit corridors. The Conditional Use requirement for converting Automotive Service Stations on the most important walking and public transit streets is removed, and consideration of pedestrian, cycling, and public transit access and safety are added to the conditional use criteria for conversion.

The ordinance seeks to simplify and clarify the Planning Code by removing obsolete sections, consolidating controls for a single use or feature into a single code sections, and harmonizing similar definitions and controls across use districts.

SUBJECT: LEGISLATION INTRODUCED

The Board of Supervisors' Land Use and Economic Development Committee has received the following proposed legislation introduced by Supervisor Chiu on May 8, 2012.

This matter is being referred to your department and commission for informational purposes only since the Planning Commission held a public hearing on March 1, 2012 (BOS File Nos. 110547 and 110548) and recommended approval by Planning Resolution No. 18553.

File No. 120471

Ordinance amending the San Francisco Planning Code Sections 102.9, 155.1, 155.4, and 228, et. seq. to: 1) expand the applicability of bicycle parking requirements; 2) exempt bicycle parking from Floor-Area ratio calculations; 3) permit the conversion of Automotive Service Stations located on Primary Transit Streets and Citywide Pedestrian Network Streets to another use without Conditional Use authorization; and 4) adopting environmental findings, Section 302 findings, and findings of consistency with the General Plan and the Priority Policies of Planning Code Section 101.1.
