

1 [Approval of a 90 Day Extension for Planning Commission Review]

3 **Resolution extending by 90 days the prescribed time within which the Planning**
4 **Commission may render its decision on a Ordinance amending Sheets SU01, SS01,**
5 **and SS02 of the San Francisco Zoning Map to: 1) add blocks and lots to the**
6 **Washington-Broadway Special Use District 1; 2) add blocks to the Waterfront Special**
7 **Use District 2; 3) delete blocks and add lots to the Waterfront Special Use District 3; 4)**
8 **make the boundaries of the Special District for Sign Illumination on Broadway co-**
9 **extensive with the Broadway Neighborhood Commercial District; 5) delete the Van**
10 **Ness Special District for Sign Illumination; and 6) add The Embarcadero from Taylor**
11 **Street to Second Street to the Special District for Scenic Streets; adopting findings,**
12 **including environmental findings, Planning Code Section 302 findings, and findings of**
13 **consistency with the General Plan and the Priority Policies of Planning Code Section**
14 **101.1.**

16 WHEREAS, On May 3, 2011, Supervisor Chiu introduced legislation that would amend
17 Sheets SU01, SS01, and SS02 of the San Francisco Zoning Map to: 1) add blocks and lots to
18 the Washington-Broadway Special Use District 1; 2) add blocks to the Waterfront Special Use
19 District 2; 3) delete blocks and add lots to the Waterfront Special Use District 3; 4) make the
20 boundaries of the Special District for Sign Illumination on Broadway co-extensive with the
21 Broadway Neighborhood Commercial District; 5) delete the Van Ness Special District for Sign
22 Illumination; and 6) add The Embarcadero from Taylor Street to Second Street to the Special
23 District for Scenic Streets; adopting findings, including environmental findings, Planning Code
24 Section 302 findings, and findings of consistency with the General Plan and the Priority

1 Policies of Planning Code Section 101.1. A copy of said legislation is on file with the Clerk of
2 the Board of Supervisors in File No. 110547 and is incorporated herein by reference; and,

3 WHEREAS, On or about May 12, 2011, the Clerk of the Board of Supervisors referred
4 the proposed ordinance to the Planning Commission, which currently is reviewing the
5 proposed ordinance; and,

6 WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by
7 resolution, extend the prescribed time within which the Planning Commission is to render its
8 decision on proposed amendments to the Planning Code that the Board of Supervisors
9 initiates; and,

10 WHEREAS, Supervisor Chiu has requested additional time for the Planning
11 Commission to review the proposed ordinance; and,

12 WHEREAS, The Board deems it appropriate in this instance to grant to the Planning
13 Commission additional time to review the proposed ordinance and render its decision; now
14 therefore be it

15 RESOLVED, That by this resolution, the Board hereby extends the prescribed time
16 within which the Planning Commission may render its decision on the proposed ordinance for
17 approximately 90 additional days, until November 12, 2011.
