3 **Resolution commending David Fernando Campos Miyares for more than five years of**
4 **exemplary public service to San Francisco as a Deputy City Attorney on the Litigation**
5 **Team, the Government Team and the Energy and Telecommunications Team of the City**
6 **Attorney's Office, and wishing him well in his future endeavors as General Counsel for**
7 **the San Francisco Unified School District.**

9 WHEREAS, The Board of Supervisors of the City and County of San Francisco wishes to
10 honor David Fernando Campos Miyares who has given more than five years of dedicated and
11 exemplary public service to San Francisco as a Deputy City Attorney, first under City Attorney
12 Louise H. Renne and then under City Attorney Dennis J. Herrera, and who is now leaving the
13 City Attorney's employment to serve as General Counsel for the San Francisco Unified School
14 District; and,

15 WHEREAS, Mr. Campos has been one of the City's best and most effective lawyers,
16 successfully representing the City in significant lawsuits and matters of great public interest, and
17 has devoted his extraordinary talents to advising and representing the offices and officials of the
18 City and County of San Francisco and the San Francisco Unified School District, including the
19 Board of Supervisors, the Board of Education and the Public Utilities Commission; and,

20 WHEREAS, The City, its voters and residents have benefited tremendously from Mr.
21 Campos' exemplary leadership and legal talents; and,

22 WHEREAS, Mr. Campos joined the City Attorney's Office in 1999 after two years of
23 private legal practice, having graduated from Harvard University School of Law and having
24 done his undergraduate work at Stanford University; and,

1 WHEREAS, As a Deputy City Attorney on the Litigation Team, Mr. Campos
2 represented the City in the landmark case against gun manufacturers; and,

3 WHEREAS, As a Deputy City Attorney on the Government Team, Mr. Campos
4 represented the San Francisco Unified School District, advising the district on many complex
5 matters, including the Federal Court desegregation consent decree; and

6 WHEREAS, For the past two years as a Deputy City Attorney on the Energy and
7 Telecommunications Team, Mr. Campos has represented the City and County of San
8 Francisco in a number of significant matters, including (i) the City's lawsuit against PG&E
9 Corporation to recover \$5 billion in ill-gotten profits that the company took from the utility and
10 its ratepayers, (ii) the City's lawsuit against energy companies for market manipulation and
11 price-gouging that cost California consumers tens of billions in excess energy costs, (iii) the
12 City's battle with PG&E to preserve the City's right to serve electricity to the San Francisco
13 Ferry Building, and (iv) the PG&E bankruptcy case; and,

14 WHEREAS, Mr. Campos has particularly distinguished himself by his ability to tackle
15 new areas of law and quickly recognize the important issues, enabling him to effectively
16 represent the City on a broad array of matters in the areas of consumer protection, public
17 education and energy; and,

18 WHEREAS, Mr. Campos' intelligence, dedication, good humor, good sense and
19 unflinching courtesy have made him a valued and trusted advisor to his clients throughout the
20 City, but particularly at the San Francisco Public Utilities Commission and the San Francisco
21 Unified School District; and,

22 WHEREAS, Mr. Campos' colleagues in the City Attorney's Office have valued him for his
23 skill and proficiency in the work he produced, and for his astute judgment, strategic thinking,
24 commitment to public service, calming influence, decency, integrity and – most of all – his
25 friendship, and they will dearly miss him in the Office; now, therefore, be it

1 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
2 hereby commends David Campos for more than five years of exemplary public service to the
3 City and County, its voters and residents; and, be it

4 FURTHER RESOLVED, That the Board of Supervisors is grateful that Mr. Campos will
5 remain in the City family and wishes him well in his future endeavors as General Counsel for
6 the San Francisco Unified School District.


