were hired to sell the property which had not developed into "South San Francisco;" and

WHEREAS, The deep water harbor, fresh water springs, and sunny climate attracted  
settlers who would start farms and businesses in the area now known as the Bayview  
Hunters Point; and

WHEREAS, In 1925, the businesses and merchants united, engaged to this day in  
commitment and service for the improvement and promotion of the Bayview Hunters Point,  
thus enhancing the quality of life for all in the community; and

WHEREAS, Presently, there are over 3,600 businesses in the community of the  
Bayview Hunters Point; now, therefore be it

RESOLVED, That the San Francisco Board of Supervisors hereby extends its highest




