Dear Supervisors Mandelman, Walton, and Sherrill (Rules Committee):

We, the Richmond District Democratic Club, are writing this letter to express our opposition and concerns regarding Marjan Philhour's bid for a seat on the San Francisco Police Commission. Our club members are quite familiar with Ms. Philhour as she has run to be our supervisor three times in our supervisorial district. As the commission is of high importance in overseeing the San Francisco Police Department and the Department of Public Accountability, our concerns about her candidacy include not only her views on policing, but also specific instances of conduct that show that she is unqualified to serve on a commission which deals with matters of public safety.

Ms. Philhour has a close relationship with the San Francisco Police Officers Association. They endorsed her in her previous bids for Supervisor and also contributed \$10,000 to her campaign for a seat on the SF DCCC. This close relationship presents a clear conflict of interest for Ms. Philhour. It's hard to see how Ms. Philhour can be objective on any issue regarding holding officers accountable for their conduct.

Also, at a time when we are experiencing an unprecedented expression of the authoritarian use of law enforcement to terrorize immigrant communities and crackdown on peaceful protests, we do not need a commissioner who advocates for a version of public safety that believes holding officers accountable is a hostile act that prevents them from doing their job. We need a police commissioner who will work with the department to make sure that policing San Francisco is done in a way that supports SFPD officers - is effective - applied equally - and holds officers accountable for their performance.

Regarding Ms. Philhour's personal conduct, during her first failed bid for Supervisor in 2016, she publicly questioned whether then-candidate Sandra Lee Fewer was actually of Asian descent, an attack which resembled the racist birther conspiracy theory attacks on President Barack

Obama. Given that the Police Commission has worked to eradicate racial bias from the police department, it is automatically disqualifying that she would resort to explicitly engaging in racial bias for her personal benefit. Ms. Philhour has never publicly or privately apologized for her statements calling into doubt the race of Supervisor Fewer.

We also have concerns about the type of people who she continually employed on her campaign despite troubling misconduct. During her most recent campaign for Supervisor, she employed a paid staffer by the name of Forrest Liu. In two separate incidents, Mr. Liu made statements

challenging Supervisor Chan and her supporters to a fight during an event and even yelled at her within five inches of her face. More details of these encounters can be found in this police

report.

Despite having knowledge of these incidents through media reports, she did not take steps to remove him from her campaign nor issue a public or private apology but instead employed him for the entire duration of her third failed bid for District 1 Supervisor.

The most recent disqualifying instance of conduct by Ms. Philhour herself is when she sought a restraining order against David Heller, the president of the Geary Boulevard Merchants' Association, after she alleged he grabbed her arm although no evidence exists of that encounter.

Mr. Heller's support for Connie Chan's re-election campaign for District 1 Supervisor was public and well-known within the campaigns. A judge denied an emergency restraining order stating the emergency restraining order "d[id] not sufficiently show acts of violence, threats of violence, or a course of conduct that seriously alarmed, annoyed, or harassed [Philhour] and caused substantial emotional distress". Furthermore, when Ms. Philhour still pursued her claim, a judge found Ms. Philhour's pursuit of the restraining order so appalling that the case was not only

dismissed but she was ordered to pay \$12,000 in attorney's fees of Mr. Heller.

Ms. Philhour's repeated harassment and bullying of people in opposition to her views, either through herself or her associates, automatically disqualifies her for any position which deals with public safety. We make no secret that our club endorsed Sandra Lee Fewer in 2016 and Connie

Chan in 2020 and 2024, the races in which Ms. Philhour ran for Supervisor in our district, but we are prompted to write this letter based on our experiences with her.

We urge you to reject Marjan Philhour's bid to serve on the San Francisco Police Commission because of grave concerns regarding her relationship with the SFPOA and the fact that she would seek to harass and cause emotional distress to those who she deems in opposition to her political viewpoints and career in the name of "public safety" and "law and order", rather than actually focus on serving and protecting the residents she would serve in this position. While some instances of conduct by Ms. Philhour and her associates are more documented than others, we hope that you take these facts presented in the totality of circumstances to oppose her nomination.
