

1 [Gift-in-Place to the Recreation and Park Department.]

3 **Resolution accepting and expending a gift in place valued approximately \$378,000**
4 **from the Trust for Public Land to the Recreation and Parks Department for the India**
5 **Basin Shoreline Park.**

7 WHEREAS, The City owns real property located in Bayview-Hunters Point known as
8 "India Basin Shoreline Park"; and,

8

9 WHEREAS, Through a series of community meetings, a conceptual plan for Phase 2
10 improvements at India Basin Shoreline Park was developed and approved by the Recreation
11 and Park Commission in 1998. Subsequently, the Phase 2 improvements were completed.
12 However, due to insufficient funding, the play area and the basketball court were not
13 constructed; and,

14

15 WHEREAS, Through a series of meetings with representation from various local
16 organizations, the conceptual improvement plan for the India Basin Shoreline Park was
17 revised ("Revised Improvement Plan") and approved by the Recreation and Park Commission
18 on July 19, 2001; and,

19 WHEREAS, The Trust For Public Land ("TPL") is a non-profit established to support
20 the preservation of open space; and,

20

21 WHEREAS, TPL is proposing to fund (a) plans and specifications for certain elements
22 of the Revised Improvement Plan, (b) project and construction management services to
23 implement the plans and specifications, and (c) physical improvements as a gift-in-place
24 ("Gift"), valued at \$378,000, to the City and County of San Francisco; and,

1 WHEREAS, On July 19, 2001, the Recreation and Park Commission recommended to
2 the Board of Supervisors to accept and expend the Gift as Resolution Number 0107-097;
3 now, therefore, be it

4 RESOLVED, That the Board of Supervisors authorizes the General Manager of the
5 Recreation and Park Department to accept and expend the Gift valued at approximately
6 \$378,000 from the Trust For Public Land for India Basin Shoreline Park.
