9 WHEREAS, The Public Works Director is authorized to revoke flower-vending stand  
10 permits pursuant to Public Works Code, Section 162; and

11 WHEREAS, The Public Works Director, in Public Works Order No. 186054, dated  
12 June 22, 2017, following a public hearing regarding the revocation of the flower-vending stand  
13 permit allowing for placement and operation of a flower-vending stand on the sidewalk at 250  
14 Post Street, and upon consideration of the facts and testimony presented at the hearing, the  
15 Public Works Director accepted the recommendation of the hearing officer to revoke the  
16 subject flower-vending stand permit; and

17 WHEREAS, Public Works Order No. 186054 is on file with the Clerk of the Board of  
18 Supervisors in File No. 170889 and is incorporated herein by reference; and

19 WHEREAS, On July 19, 2017, Harold Hoogasian filed a timely appeal to the decision  
20 of the Public Works Director; and

21 WHEREAS, On September 26, 2017, this Board held a duly noticed public hearing to  
22 consider the appeal of the flower-vending stand permit by Appellant; and

23 WHEREAS, This Board has reviewed and considered the subject flower-vending stand  
24 permit revocation, the appeal letter, and the other written records before the Board of

1 Supervisors, and heard testimony and received public comment regarding the flower-vending  
2 stand permit revocation; now, therefore, be it

3           MOVED, That the Board conditionally disapproves the decision of the Public Works  
4 Director concerning revocation of the subject flower-vending stand permit and hereby upholds  
5 the appeal of Harold Hoogasian, subject to the adoption of written findings of the Board in  
6 support of this determination.
