3 **Ordinance amending Section 16.93-2 of the San Francisco Administrative Code to allow**  
4 **the Cash for Care Special Account to participate in the annual joint fundraising drive.**

8 Be it ordained by the People of the City and County of San Francisco:

9 Section 1. The San Francisco Administrative Code is hereby amended to read as  
10 follows:

11 SEC. 16.93-2. SELECTION OF AGENCIES ELIGIBLE TO PARTICIPATE IN THE  
12 ANNUAL JOINT FUNDRAISING DRIVE.

13 Participation shall be limited to any Mayor's fund which is created to further social  
14 causes, those funds being the Mayor's Youth Fund, the Mayor's Homeless Fund, and the  
15 Mayor's Youth Employment Summer Program, the Cash for Care Special Account established  
16 in Section 10.100-368 of the San Francisco Administrative Code, and to all federated  
17 agencies that meet the following criteria, as determined by the Board of Supervisors:

18 (a) An eligible charitable agency must be a federated agency representing 10 or  
19 more charitable organizations, of which at least 50 percent shall represent organizations  
20 located in the counties of San Francisco, San Mateo, Santa Clara, Alameda, Contra Costa,  
21 and Marin.

22 (b) The federated agency, ~~or Mayor's fund,~~ or the Cash for Care Special Account  
23 must certify to the Board of Supervisors that the Federal Internal Revenue Service has  
24 determined that contributions to all of the represented charitable organizations, ~~or Mayor's~~  
25 funds, or the Cash for Care Special Account are tax deductible.

1 (c) The federated agency must have been in existence with 10 or more qualified  
2 charities for at least one year prior to the date of application and provide satisfactory evidence  
3 to that effect at the time of filing an application with the Board. Mayor's funds shall submit their  
4 most recent financial statement to the Board of Supervisors on an annual basis. The advisory  
5 committee of the Cash for Care Special Account shall submit to the Board of Supervisors and  
6 its Finance or Budget committees or successor committees on an annual basis a written  
7 report of revenues to and expenditures from the Cash for Care Special Account during the  
8 year covered by the report.

9 (d) The federated agency must submit its most recent certified audit at the time of  
10 filing an application with the Board.

11 (e) Agencies that wish to participate in the Annual Drive are required to submit  
12 applications to the Board of Supervisors that include all information that may be relevant to  
13 the criteria listed in this Section.
