

1 [Caltrain Feeder Service Agreement - Peninsula Corridor Joint Powers Board - \$250,000
2 Base Annual Payment]

3 **Resolution retroactively approving a Feeder Service Agreement between the City and**
4 **County of San Francisco and the Peninsula Corridor Joint Powers Board, for payment**
5 **to the San Francisco Municipal Transportation Agency for Muni feeder trips, for a base**
6 **annual payment of \$250,000 per fiscal year, for a term beginning on July 1, 2016, and**
7 **continuing until terminated by either party.**

9 WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) provides
10 transit connections to and from the Caltrain terminal at Fourth and King Streets in San
11 Francisco, allowing Caltrain customers to use Muni to reach locations away from the Caltrain
12 terminal; and

13 WHEREAS, Since 1998, when the SFMTA enhanced this service through the addition
14 of Muni Metro light rail service, the Peninsula Corridor Joint Powers Board (JPB) and the
15 SFMTA agreed that the JPB would be obligated to pay the full cost of service on dedicated
16 express bus service to and from the Caltrain terminal; and

17 WHEREAS, In recent years, the JPB has paid approximately \$200,000 per year to the
18 SFMTA for the feeder service; in the fiscal year ending June 30, 2016, the JPB will pay
19 \$250,000 to the SFMTA; and

20 WHEREAS, The SFMTA and the JPB wish to continue to coordinate this feeder transit
21 service for the benefit of customers of both agencies and are proposing a base annual
22 payment of \$250,000 for FY2016-2017, adjusted annually based on the percentage change of
23 the San Francisco Bay Area Consumer Price Index, which represents a significant discount
24 on the SFMTA's actual operating cost of the service; and

1 WHEREAS, On February 26, 2016, the Planning Department determined that the
2 Feeder Service Agreement is not a “project” for purposes of environmental review under the
3 California Environmental Quality Act (CEQA) pursuant to CEQA Guidelines, Section 15060(c);
4 and

5 WHEREAS, Said determination is on file with the Clerk of the Board of Supervisors in
6 File No. 160955 and is incorporated herein by reference; and

7 WHEREAS, On June 28, 2016, the SFMTA Board of Directors adopted Resolution
8 No. 16-076, which authorized the Director of Transportation to execute the Feeder Service
9 Agreement between the City and the JPB for payment to the SFMTA for Muni feeder trips, for
10 the term beginning on July 1, 2016, and continuing until terminated as provided in the
11 Agreement; the Agreement is on file with the Clerk of the Board of Supervisors in
12 File No. 160955 and incorporated herein by reference; now, therefore, be it

13 RESOLVED, That the Board of Supervisors retroactively approves execution of the
14 Feeder Service Agreement between the City and County of San Francisco and the Peninsula
15 Corridor Joint Powers Board for payment to the SFMTA for Muni feeder trips, for a base
16 annual payment of \$250,000 per fiscal year, for a term beginning on July 1, 2016, and
17 continuing until terminated by either party as provided in the Agreement.
