2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF-SALE
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 698 3RD STREET
4 TO 681 3RD STREET TO KIM, JOSEPH YOUNG KYU DBA 3RD & TOWNSEND
5 CORNER STORE WILL SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF
6 THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE
7 WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS
8 CODE; WITH CONDITIONS.

10 WHEREAS, Kim, Joseph Young Kyu is seeking transfer of a Type 21 off-sale
11 general alcoholic beverage control license for 3rd & Townsend Corner Store located at
12 681 3rd Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
20 off-sale general alcoholic beverage control license from 698 3rd Street to 681 3rd Street
21 for Kim, Joseph Yong Kyu dba 3rd & Townsend Corner Store, will serve the public
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) Sales and service of alcoholic beverages shall be permitted only
24 between the hours of 7:00 AM and 6:30 PM each day of the week. 2) The petitioner
25 shall be responsible for maintaining free of litter the area in front of and adjacent to the

1 premises over which they have control. 3) No wine shall be sold with an alcoholic
2 content greater than 15% by volume. 4) Wine shall not be sold in bottles or containers
3 smaller than 750 ml, and wine coolers shall not be sold in units of less than a four pack.
4 5) No person under the age of 21 shall sell or package alcoholic beverages.




