6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the
8 Immigrant Rights Commission, pursuant to the provisions of Ordinance No. 211-97, for the
9 terms specified:

10 Vera Haile, succeeding herself, term expired, seat 1, must have a demonstrated
11 knowledge of and interest in the health, human service, educational, or employment issues
12 that affect immigrants residing in San Francisco, for a two-year term ending June 6, 2008.

13 Gilberto Alexander, succeeding himself, term expired, seat 2, must have a
14 demonstrated knowledge of and interest in the health, human service, educational, or
15 employment issues that affect immigrants residing in San Francisco, for a two-year term
16 ending June 6, 2008.

17 Ivy Lee, succeeding herself, term expired, seat 5, must have a demonstrated
18 knowledge of and interest in the health, human service, educational, or employment issues
19 that affect immigrants residing in San Francisco, for a two-year term ending June 6, 2008.

20 Toye Moses, succeeding Zina Spektor, resigned, seat 11, must be an immigrant to the
21 United States who is appointed in accordance with Section 4.101 of the Charter. In addition,
22 members shall have a demonstrated knowledge of and interest in the health, human service,
23 educational, or employment issues that affect immigrants residing in San Francisco, for the
24 unexpired portion of a two-year term ending June 6, 2007.
