3 **Motion adopting findings in response to written objections to adoption of amendments**
4 **to the Bayview Hunters Point Redevelopment Plan and the Hunters Point Shipyard**
5 **Redevelopment Plan that were delivered to the Clerk of the Board of Supervisors**
6 **before or at the public hearing on adoption of the Redevelopment Plan amendments,**
7 **pursuant to the requirements of the California Community Redevelopment Law.**

9 WHEREAS, A public hearing on adoption of amendments to the Redevelopment Plans
10 for Bayview Hunters Point and Hunters Point Shipyard (the "Redevelopment Plan
11 Amendments") was duly noticed and held by the Board of Supervisors on October 22, 2024,
12 in accordance with the California Community Redevelopment Law, California Health and
13 Safety Codes, Sections 33000 et seq. (the "Community Redevelopment Law"); and

14 WHEREAS, Various written objections to adoption of the Redevelopment Plan
15 Amendments were delivered to the Clerk of the Board of Supervisors prior to the hour set for
16 the hearing thereon and various written objections to adoption of the Redevelopment Plan
17 Amendments were presented to the Clerk during the hearing; and

18 WHEREAS, The Board of Supervisors deferred adoption of the Redevelopment Plan
19 Amendments for one week to provide for consideration of the objections and adoption of
20 written findings in response thereto, as required by Section 33364 of the Community
21 Redevelopment Law; and

22 WHEREAS, The Successor Agency to the Redevelopment Agency of the City and
23 County of San Francisco, commonly known as the Office of Community Investment and
24 Infrastructure, has prepared a written response to all such written objections describing the
25 disposition of the issues raised and addressing the written objections in detail, including

1 reasons for not accepting the specified objections and suggestions, and containing a good-
2 faith, reasoned analysis of such issues (the "Response"); and

3 WHEREAS, A copy of the Response is on file with the Clerk of the Board of
4 Supervisors in File Nos. 240877, 240878, 240885, and 241051 and is incorporated herein by
5 reference; now, therefore, be it

6 MOVED, Pursuant to the requirements of the Community Redevelopment Law,
7 Sections 33363 and 33343, the Board of Supervisors hereby adopts as its own the Response,
8 as though fully set forth herein, including its written findings responding to the public's
9 objections to adoption of the Redevelopment Plan Amendments, for the reasons set forth in
10 the Response.


