4	Resolution retroactively authorizing the Planning Department to accept and expend a
5	grant award of \$7,000,000 for the period from January 22, 2025, through September 30,
6	2030, from the United States Department of Housing and Urban Development's

13	WHEREAS, San Francisco is facing a severe housing crisis, with housing costs among
14	the highest in the country - the median home price exceeds \$1.4 million, and rents average
15	\$3,500 per month for a one-bedroom apartment; and
16	WHEREAS, Key drivers of the crisis include limited land, restrictive zoning, high
17	construction costs, and lengthy permitting processes, especially for small builders; and
18	WHEREAS, In January 2023, San Francisco adopted the Housing Element 2022
19	Update, a comprehensive vision for preserving, producing, and protecting housing, with a
20	target of producing 82,000 new units, including at least 33,000 units affordable at very low
21	and low incomes and 14,000 units affordable at moderate incomes, by 2031; and
22	WHEREAS, The Housing Element includes more than 42 policy goals and over 350
23	implementation programs that center racial and social equity in the planning process, as well
24	as prioritizing an increase in housing production, while seeking to redress harm from past
25	

1 government actions, such as redlining and urban renewal projects that devastated

2 communities of color; and

WHEREAS, In February 2023, the Mayor issued the "Housing for All" Executive
Directive to implement the Housing Element and direct City agencies to reduce barriers to
producing affordable and mixed-income housing; and

6 WHEREAS, San Francisco has already accomplished many efforts to reduce barriers
7 to building affordable and mixed-income housing, by reducing impact fees, and removing
8 unnecessary processes and hearings; and

9 WHEREAS, To meet its housing goals, the City continues to explore additional
10 opportunities, including through the rehabilitation of low-income housing, rezoning to allow
11 more multifamily housing and affordable housing in high-opportunity areas, supporting new
12 funding streams for affordable housing, streamlining permit approvals, and continuing to invest
13 in the stabilization of residents and communities at risk of displacement; and

WHEREAS, The City previously applied for, but did not receive \$2,000,000 in grant
 funding as part of the Round 1 Pathways to Removing Obstacles to Housing ("PRO Housing")
 grant program; and

17 WHEREAS, In anticipation of that the Round 1 PRO Housing grant funding, the City

18 appropriated \$2,000,000 in the Fiscal Year 24/25 budget towards activities related to

19 increasing housing opportunity; and

WHEREAS, On August 13, 2024, the U.S. Department of Housing and Urban
 Development, issued a Notice of Funding Opportunity for Round 2 of the PRO Housing grant

program to identify and remove barriers to affordable housing production and preservation;

23 and

WHEREAS, The Planning Department on October 15, 2024, submitted its application
 titled, "Round 2 Application: FY 24 Pathways to Removing Obstacles to Housing;" and

WHEREAS, The grant program runs through September 30, 2030, and would enable
 the City to improve housing conditions for its equity communities and increase production and
 preserve housing for current and future populations; and
 WHEREAS, On January 14, 2025, the U.S. Department of Housing and Urban

- 5 Development issued a notice that San Francisco was selected to receive \$7,000,000 in
- 6 funding over a period of five years, from January 22, 2025, through September 30, 2030; and

WHEREAS, Pursuant to the grant terms, the City will leverage \$9,915,627 in City staff
time and matching grants to yield higher impact across the grant activities; and

9 WHEREAS, The grant will provide funding for the Planning Department to: integrate its 10 permitting systems and updates its municipal codes to improve permitting; improve

11 consistency and transparency in the entitlement process; preserve affordable housing by

## MANDATE STATEMENT

City Administrative Code Section 10.170-1 states that accepting federal, state, or third-party grant funds in the amount of \$100,000 or more, including any City matching funds required by the grant, is subject to Board of Supervisors approval.

City Charter Section 9.118(a) states that contracts entered into by a department, board, or commission that (i) have anticipated revenues of \$1 million or more, or (ii) have anticipated revenues of \$1 million or more and require modifications, are subject to Board of Supervisors approval.

## BACKGROUND

The U.S. Department of Housing and Urban Development (HUD) provides grant funding to local governments to address local housing barriers (such as outdated land use policies and regulations and risks associated with a housing stock that is aging) through the Pathways to Removing Obstacles to Housing (PRO Housing) program. The Planning Department applied for \$2.0 million in grant funding as part of the Round 1 grant program but did not receive an award.<sup>1</sup> The Planning Department applied for \$7.0 million in grant funding in response to the August 2024 Round 2 Notice of Funding Opportunity (NOFO) for the program and received a notice of award in January 2025.

## DETAILS OF PROPOSED LEGISLATION

The proposed resolution would retroactively authorize the Planning Department to accept and expend a \$7,000,000 grant award from the United States Department of Housing and Urban Development's Pathways to Removing Obstacles to Housing program for the period from January 22, 2025 through September 30, 2030 and approve the grant agreement.

The grant is retroactive because the Planning Department received notice of the award on January 24, 2025 (after the grant start date of January 22, 2025) and the proposed resolution was introduced on March 11, 2025.

## Matching Funds

According to Round 2 NOFO, the program does not require matching funds but awarded a maximum of 10 points (out of 100 total points) to proposals that leverage other funding sources equal to at least 50 percent of the grant. The Planning Department's proposal included \$9.9 million in other funds equal to 142 percent of the \$7.0 million grant award and received the full

10 points for leveraging other funds. As detailed in Exhibit 2 below, the \$9.9 million in other funds includes \$7.8 million from the City's General Fund and \$2.1 million from other grants.

## **Grant Activities**

According to the Planning Department's application for grant funds. The grant and other city funds will support the following activities:

- 1. **Development process improvements** to accelerate permitting timelines and improve consistency in the entitlement process, including improvements to permitting systems, updates to technology, policy, and municipal codes, custom software to improve transparency and the applicant experience (such as an impact fee calculator, online application portal, and project review workspace for planners).
- 2. Affordable housing production, preservation, and stabilization activities to preserve the City's Single Room Occupancy (SRO) buildings and promote affordable housing development on sites owned by faith-based organizations, including a capital needs assessment of Single Room Occupancy (SRO) buildings and legislative changes and capital funding to replace or rehabilitate SROs; and trainings and permitting support for Faith Based Organizations.
- 3. Expand housing types, particularly in high-resourced neighborhoods, including development of pre-approved schematic designs for small-scale multi-family housing (two to nine units), updates to land use controls and tenant protections, and identification of publicly owned sites suitable for housing development.
- 4. **Prioritize community benefits in equity communities** to prevent displacement in lowincome communities of color where most of the recent housing production has occurred and to ensure existing residents benefit from development. Specifically, this activity includes drafting and implementing a community benefits framework to assess existing requirements and use of fee revenues and determine how desired community benefits could be addressed; and development of policies and legislation to implement community benefits without increasing the cost of housing production and preservation.

## **Performance Goals**

According to the NOFO, the Planning Department must comply with HUD reporting requirements, including submission of quarterly progress reports throughout the grant term. Exhibit 1 shown below shows potential performance goals for the grant activities according to the Planning Department's grant application.

Grant activities and goals align with the City's policy goals in the Housing Element 2022 Update. The Board of Supervisors could request that the Planning Department report annually on the proposed grant performance measures during the department's budget presentation.

## FISCAL IMPACT

Grant activities are funded by the proposed \$7.0 million HUD grant (41 percent), approximately \$7.8 million from the City's General Fund (46 percent), and other grants (13 percent). Exhibit 2 below shows the proposed grant budget.

The proposed grant, along with City sources and other grants, provide approximately \$10.5 million for salaries and benefits for City staff, which reflects 62 percent of the proposed budget. Over the five-year and eight-month term, the budget funds 40.07 full-time equivalent (FTE) positions cumulatively, or approximately 7.0 to 8.0 FTE annually, as shown in Exhibit 3 below. According to Planning Department staff, all positions are existing and none are currently vacant.

## POLICY CONSIDERATION

## **Federal Funding Disbursement**

According to Planning Department staff, some of the activities include work that is currently ongoing or planned within City department programs and some of the activities are new activities and rely on the proposed grant funding. For example, contracts with third-party firms for improved permitting systems rely on grant funds. Such contracts would not be awarded if the grant funds were paused or cancelled. Staff supported work to improve workflows and use of

existing systems is matched with funding from the General Fund and could continue without grant funds.

Based on the grant budget, Activities 1 and 2 would be more greatly impacted than Activities 3 and 4 if the PRO Housing grant funds are not disbursed. As shown in Exhibit 4 below, the HUD PRO Housing grant reflects at least half of all funding for Activities 1 and 2, and less than one-third of all funding for Activities 3 and 4. Including the \$1.0 million DOT grant, which was previously awarded to the SFMTA, federal funding reflects 47 percent of Activity 3 funding.

The Grantee agrees to assume all of the responsibilities for environmental review, decision making, and actions, as specified and required in regulations issued by the Secretary pursuant to Section 104(g) of Title I and published in 24 CFR Part 58. The Grantee further acknowledges its responsibility for adherence to the Agreement by sub-recipient entities to which it makes funding assistance hereunder available.

- 8. Additional Requirements.
  - (a) These additional requirements are attached to the Funding Approval/Agreement (form HUD-7082) (the "Agreement") between HUD and the Grantee for grant number B-24-PH-06-0003 and apply to all grantees receiving funds appropriated under Public Law 118-42 as part of the Pathways to Removing Obstacles to Housing (PRO Housing) program. By signing the Agreement, the Grantee agrees to these additional requirements on the use of this PRO Housing grant, as may be amended from time to time by the Secretary.
  - (b) The submissions for assistance incorporated into the Agreement include the Grantee's PRO Housing action plan(s) and amendments, including the certifications, assurances, and any documentation the Grantee is required to submit for the award. Until grant closeout, the Grantee must continue to adhere to its submissions, unless amended in accordance with PRO Housing requirements.
  - (c) The requirement of the Agreement to comply with the Housing and Community Development Act of 1974, as amended, and the requirements at 24 CFR part 570 are modified to incorporate the requirements of the Consolidated Appropriations Act, 2024 (Public Law 118-42) and the FY24 Pathways to Removing Obstacles to Housing (PRO Housing) Notice of Funding Opportunity (NOFO) FR-6800-N-98, (as now in effect and as may be modified from time to time). The Grantee agrees to comply with the NOFO, and any future Federal Register notices published by HUD that apply to PRO Housing under Public Law 118-42. Future Federal Register notices will apply prospectively from their applicability date, and to costs reimbursed from the grant after their applicability date, as provided in the notices and in 8.(d).
  - (d) The period of performance and single budget period for the Funding Assistance shall each begin on the date specified in item 4 and shall each end on September 30, 2030. The Grantee shall not incur any obligations to be paid with such assistance after September 30, 2030.
  - (e) Any program income received before or after closeout of the grant is treated as additional PRO Housing grant funds, subject to the requirements of the FY24 PRO Housing NOFO, and must be used in accordance with the Grantee's PRO Housing Action Plan. Except as amended by the FY24 PRO Housing NOFO, a grantee that is a local government, multijurisdictional entity or metropolitan planning organization shall comply with regulatory provisions at 24 CFR part 570 subparts A, C, D, J, K, and O, and a grantee that is a State shall comply with regulatory provisions at 24 CFR part 570 subpart I. To the maximum extent feasible, program income shall be used or distributed before additional withdrawals from the U.S. Treasury are made, except as provided in the FY24 PRO Housing NOFO.

- (f) The Grantee must use the Grant Funds only for costs (including indirect costs) that meet the applicable requirements in 2 CFR part 200 (including appendices). The Grantee's indirect cost rate information is as provided in Addendum #1 to this Agreement. The Grantee must immediately notify HUD upon any change in the Grantee's indirect cost rate, so that HUD can amend the Agreement to reflect the change if necessary.
- (g) In addition to the conditions contained on form HUD 7082, the grantee shall comply with requirements established by the Office of Management and Budget (OMB) concerning the Dun and Bradstreet Data Universal Numbering System (DUNS); the System for Award Management (SAM.gov.); the Federal Funding Accountability and Transparency Act as provided in 2 CFR part 25, Universal Identifier and General Contractor Registration; and 2 CFR part 170, Reporting Subaward and Executive Compensation Information.
- The grantee shall ensure that no PRO Housing funds are used to support any (h) Federal, State, or local projects that seek to use the power of eminent domain, unless eminent domain is employed only for a public use. For the purposes of this requirement, public use shall not be construed to include economic development that primarily benefits private entities. Any use of funds for mass transit, railroad, airport, seaport or highway projects as well as utility projects which benefit or serve the general public (including energy-related, communication-related, water- related and wastewater-related infrastructure), other structures designated for use by the general public or which have other common-carrier or public-utility functions that serve the general public and are subject to regulation and oversight by the government, and projects for the removal of an immediate threat to public health and safety or brownfield as defined in the Small Business Liability Relief and Brownfields Revitalization Act (Public Law 107–118) shall be considered a public use for purposes of eminent domain.
- (i) The Grantee or other entity that directly or indirectly receives PRO Housing funds may not sell, trade, or otherwise transfer all or any such portion of such funds to another such entity in exchange for any other funds, credits or non-Federal considerations, but must use such funds for activities eligible under title I of the Act or the FY24 PRO Housing NOFO.
- E.O. 12372-Special Contract Condition Notwithstanding any other provision of this agreement, no funds provided under this agreement may be obligated or expended for the planning or construction of water or sewer facilities until receipt of written notification from HUD of the release of funds on completion of the review procedures required under Executive Order (E.O.) 12372, Intergovernmental Review of Federal Programs, and HUD's implementing regulations at 24 CFR Part 52. The recipient shall also complete the review procedures required under E.O. 12372 and 24 CFR Part 52 and receive written notification from HUD of the release of funds before obligating or expending

any funds provided under this agreement for any new or revised activity for the planning or construction of water or sewer facilities not previously reviewed under E.O. 12372 and implementing regulations.

- (k) PRO Housing funds may not be provided to a for-profit entity pursuant to section 105(a)(17) of the Act unless such activity or project has been evaluated and selected in accordance with Appendix A to 24 CFR 570 "Guidelines and Objectives for Evaluating Project Costs and Financial Requirements." (Source P.L. 113-235, Consolidated and Further Continuing Appropriations Act, 2015, Division K, Title II, Community Development Fund).
- (1) The Grantee must comply with the requirements of the Build America, Buy America (BABA) Act, 41 USC 8301 note, and all applicable rules and notices, as may be amended, if applicable to the Grantee's infrastructure project. Pursuant to HUD's Notice, "Public Interest Phased Implementation Waiver for FY 2022 and 2023 of Build America, Buy America Provisions as Applied to Recipients of HUD Federal Financial Assistance" (88 FR 17001), any funds obligated by HUD on or after the applicable listed effective dates, are subject to BABA requirements, unless excepted by a waiver.
- (m) Waste, Fraud, Abuse, and Whistleblower Protections. Any person who becomes aware of the existence or apparent existence of fraud, waste or abuse of any HUD award must report such incidents to both the HUD official responsible for the award and to HUD's Office of Inspector General (OIG).
