13 "FINAL MAP, PLANNED DEVELOPMENT, MISSION BAY (N3-N3A)", RECORDED MARCH  
14 15, 2001, IN BOOK Z OF MAPS AT PAGES 175-178, INCLUSIVE, OFFICIAL RECORDS OF

21 Planning Department, by its letter dated June 14, 2006, that the proposed subdivision is  
22 consistent with the objectives and policies of the General Plan and the Eight Priority Policies  
23 of Section 101.1 of the Planning Code; and be it


24       FURTHER MOVED, That the San Francisco Board of Supervisors adopts as its own

5 the Director of the Department of Public Works to enter all necessary recording information on  
6 the Final Map and authorizes the Clerk of the Board of Supervisors to execute the Clerks  
7 statement as set forth herein; and be it

8 FURTHER MOVED, That approval of this map is also conditioned upon compliance by  
9 the subdivider with all applicable provisions of the Mission Bay Subdivision Code and  
10 amendments thereto.
