21 it


22 FURTHER MOVED, That approval of this map is also conditioned upon compliance by



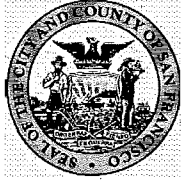
