

1 [Settlement of Litigation]

2 AUTHORIZING SETTLEMENT OF LITIGATION BY THE CITY AND COUNTY OF SAN
3 FRANCISCO AGAINST MARY L. LOBUGLIO BY ACCEPTING CONSIDERATION IN THE
4 TOTAL AMOUNT OF \$71,228.00 PLUS INTEREST AT THE RATE OF 10% PER ANNUM
5 PAYABLE IN CASH ON OR BEFORE OCTOBER 30, 1998 AND FILING STIPULATION
6 FOR ENTRY OF JUDGMENT UPON DEFAULT TO SECURE PAYMENT.

7 BE IT ORDAINED by the People of the City and County of San Francisco.

8 **SECTION 1.** The Tax Collector Attorney in the Treasurer/Tax
9 Collector Department is hereby authorized and directed to settle the
10 controversy in the action City and County of San Francisco v. Mary L.
11 LoBuglio, San Francisco Superior Court No. 994516 by filing the
12 Payment Agreement and Stipulation for Entry of Judgment upon Default,
13 a copy of which is attached to this Ordinance and labeled Exhibit 1;
14 and accepting the sum of \$71,228 plus interest computed at the rate of
15 ten percent (10%) per annum from June 1, 1998 to the date of payment.
16 Full payment shall be made on or before October 30, 1998.

17 **SECTION 2.** After full payment of the amount specified in Section
18 1, the Tax Collector Attorney is directed to prepare and file a
19 dismissal with prejudice in the action City and County of San
20 Francisco v. Mary L. LoBuglio, San Francisco Superior Court No.
21 994516, thereby terminating all litigation in this case.

22 **SECTION 3.** Should Mary L. LoBuglio fail to pay the Settlement
23 Amount, including interest as specified in Section 1 by October 30,

1 1998, the Tax Collector Attorney is directed to immediately enter
2 judgment against Mary L. LoBuglio in the amount of the complaint plus
3 additional charges as authorized in paragraph 4 of the Payment
4 Agreement and Stipulation for Entry of Judgment Upon Default.
5 Time is of the essence in this settlement.




