5 for \$32,000; the lawsuit was filed on January 31, 2005 in San Francisco Superior Court,
6 Case No. 436930; entitled Jane Martin, et al. v. City and County of San Francisco, et al.

7 Be it ordained by the People of the City and County of San Francisco:

8 Section 1. The City Attorney is hereby authorized to settle the portion of the action
9 entitled "Jane Martin, et al. v. City and County of San Francisco, et al." San Francisco
10 Superior Court, Court No. 436930, as it relates only to plaintiffs Monte & Joanne Stott and
11 Stott & Associates, Inc., by the payment of \$32,000, and excluding the claim by these
12 plaintiffs for diminution of property value, attorney's fees, costs and interest, which will be
13 addressed in later proceedings.

14 Section 2. The above-named action was filed in San Francisco Superior Court on
15 January 31, 2005, and the following settling parties were named in the lawsuit: Plaintiffs
16 Monte & Joanne Stott and Stott & Associates, Inc. and Defendant City and County of San
17 Francisco.
