[Accept and Expend Grant - San Francisco Alternative Fuels Readiness Project - \$300,000]

WHEREAS, In 2004, the Department of the Environment and the San Francisco Public Utilities Commission released a "Climate Action Plan for San Francisco" identifying transportation, energy efficiency, renewable energy, and solid waste measures that could achieve significant greenhouse gas reductions; and

WHEREAS, Forty per cent of the greenhouse gases generated in San Francisco are attributable to transportation; and

WHEREAS, Alternative Fuel Vehicles (AFV) significantly reduce greenhouse gases compared to vehicles with internal combustion engines; and

WHEREAS, The California Energy Commission has awarded a grant of \$300,000 to the Department of the Environment to develop comprehensive data on AFV and Alternative Fuel Infrastructure (AFI) utilization, and to prepare a San Francisco AFV Readiness Plan and develop AFV outreach activities; and

WHEREAS, The promotion of AFV-friendly public policies and incentives in the City will provide a model for region wide adoption in the greater San Francisco Bay Area and contribute to San Francisco's identification as a continuing leader in creating programs and services with measurable environmental impact; and

WHEREAS, The term of this grant is from June 30, 2014 to September 30, 2016; and

WHEREAS, The budget includes a provision for indirect costs in the amount of \$54,857; and

WHEREAS, No grant funds will be spent until approval is given by the Board; and WHEREAS, The grant does not require an Annual Salary Ordinance (ASO) amendment; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Director of the Department of the Environment to accept and expend a grant in the amount of \$300,000 from the California Energy Commission to accelerate the adoption of Alternative Fuel Vehicles and promote the use of Alternative Fuel Infrastructure.
