3 Ordinance authorizing settlement of the lawsuit filed by Sandra Ramos against the City
4 and County of San Francisco for \$60,000; the lawsuit was filed on October 12, 2011, in
5 the United States District Court for the Northern District of California, Case No. C-11-
6 5033-WHA, entitled Sandra Ramos v. City and County of San Francisco; other material
7 terms of said settlement are reimbursement to Plaintiff of up to \$2,500 for the services
8 of an organizational consultant.

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. The City Attorney is hereby authorized to settle the action entitled Sandra
11 Ramos v. City and County of San Francisco, et al., U.S. District Court (N.D.Cal.) Case No. C-
12 11-5033 WHA, by the payment of \$60,000 and reimbursement to Plaintiff of up to \$2,500 for
13 the services of an organizational consultant.

14 Section 2. The above-named action was filed in the United States District Court for the
15 Northern District of California on October 12, 2011, and the following parties were named in
16 the lawsuit: Sandra Ramos, Plaintiff, and City and County of San Francisco, Defendant.
