6 **lawsuit was filed on March 7, 2017, in the San Francisco Superior Court, Case No. CGC-**  
7 **17-557438; entitled Colin James Baca v. David George Camerlo, et al.; the lawsuit**  
8 **involves alleged personal injury from a vehicle collision and a subrogation claim for**  
9 **workers compensation benefits paid to Colin James Baca.**

11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
13 authorizes the City Attorney to settle the lawsuit filed by Colin James Baca against the City  
14 and County of San Francisco for \$230,000, and to settle the related Complaint in Intervention  
15 of XL Specialty Insurance Company in the amount of \$35,000; the lawsuit was filed on March  
16 7, 2017, in the San Francisco Superior Court, Case No. CGC-17-557438; entitled Colin  
17 James Baca v. David George Camerlo, et al.; the lawsuit involves alleged personal injury from  
18 a vehicle collision and a subrogation claim for workers compensation benefits paid to Colin  
19 James Baca.

20 Section 2. The above-named action was filed in San Francisco Superior Court on  
21 March 7, 2017, and the following parties were named in the lawsuit: Plaintiff: Colin James  
22 Baca; Defendants: David George Camerlo and City and County of San Francisco; Intervenor:  
23 XL Specialty Insurance Company.
