[Accept-Expend State Grant and Amend Annual Salary Ordinance, FY 2008-09]

Ordinance authorizing the Mayor's Office of Criminal Justice to retroactively accept and expend a grant in the amount of \$400,000 from the California Governor's Office of Emergency Services (OES) for gang violence reduction activities, and amending the Annual Salary Ordinance (ASO) to provide for the creation of certain grant funded positions.

WHEREAS, The City and County of San Francisco applied for funding to the Governor's Office of Emergency Services (OES) for the California Gang Reduction, Intervention and Prevention Program (CalGRIP), and was awarded four hundred thousand dollars (\$400,000) on March 3, 2008; and

WHEREAS, The Mayor's Office of Criminal Justice is the lead fiscal agency in administering the CalGRIP funded project; now, therefore, be it

ORDAINED, That the Mayor's Office of Criminal Justice is authorized to accept and expend a grant in the amount of \$400,000 in FY 2008-09 from OES to implement gang violence reduction activities; and be it

FURTHER ORDAINED, That the Mayor's Office of Criminal Justice in partnership with the San Francisco Adult Probation Department, and the Omega Boys Club/Street Soldiers will be responsible for coordination and day-to-day operations of the planning and implementation phases of this grant; and be it

FURTHER ORDAINED, That the Mayor's Office of Criminal Justice will be responsible for the fiscal, programmatic and administrative reporting to OES; and be it

FURTHER ORDAINED, That the City and County of San Francisco agrees to provide all matching funds required for said project (including any amendment thereof), and abide by the statutes and regulations governing the CalGRIP project as well as the terms and conditions of the Grant Agreement as set forth by the OES; and be it

1 FURTHER ORDAINED, that the Annual Salary Ordinance is hereby amended as follows:






