2 - Recruitment and Training - \$365,700]

3 **Resolution retroactively authorizing the Sheriff's Department of the City and**
4 **County of San Francisco to accept and expend \$365,700 from the Board of State**
5 **and Community Corrections (BSCC) to assist local agencies for recruitment and**
6 **training of corrections and probations personnel adherence to standards**
7 **established by BSCC from July 1, 2019, through June 30, 2020.**

9 WHEREAS, The Standards and Training for Corrections (STC) Program operates
10 under BSCC (formally the Corrections Standards Authority) was established on July 1,
11 1980, under the California Penal Code (Part 3, Title 7, Chapter 5, Sections 6024 through
12 6036); the STC Program provides a standardized, state-coordinated local corrections
13 selection and training program; the intent of the program is to improve the skills and raise
14 the level of competency of local corrections and probations officers; and

15 WHEREAS, The grant does not require an ASO amendment; and

16 WHEREAS, The grant does not require matching fund; and

17 WHEREAS, The terms of the legislation establishing the program do not allow
18 indirect or administrative costs; now, therefore, be it

19 RESOLVED, That the Sheriff's Department is hereby directed to accept and
20 expend in the amount of \$365,700 from BSCC for criminal justice purposes; and, be it

21 FURTHER RESOLVED, That the funds received hereunder shall be used to
22 reimburse training expenditures not reimbursed by the Peace Officers Standards and
23 Training Program (POST); and, be it


24 FURTHER RESOLVED, That the Board of Supervisors does hereby waive
25 inclusion of indirect costs in the grant budget; and, be it

1 FURTHER RESOLVED, That the Sheriff of the San Francisco Sheriff Office is here
2 by authorized and empowered to execute, deliver and perform, in the name of City and
3 County of San Francisco, all applications, agreements, amendments and payment
4 requests necessary to secure the STC grant funds and implement and carry out the
5 purposes specified in the applicable grant application.




