11 Be it ordained by the People of the City and County of San Francisco:

12 Section 1. Environmental Findings. The Planning Department has determined that the
13 actions contemplated in this Ordinance are in compliance with the California Environmental
14 Quality Act (California Public Resources Code sections 21000 et seq.). Said determination is
15 on file with the Clerk of the Board of Supervisors in File No. _____ and is
16 incorporated herein by reference.

17 Section 2. The San Francisco Fire Code is hereby amended by amending Appendix
18 Chapter 1 Section 112.8 to read as follows:

19 112.8 [For SF] High-Rise Inspection Fees. For inspections of high-rise structures
20 pursuant to Section 13217 of the *California Health and Safety Code*, the owner of the
21 structure shall pay a fee to cover the department's costs of inspection. Such fee shall be
22 calculated on the basis of ~~\$11.00~~ \$12.00 per 1000 square feet of gross floor area, and shall be
23 collected by the fire department.

1 Section 3. The San Francisco Fire Code is hereby amended by amending Appendix
 2 Chapter 1 Section 112.15 to read as follows:

3 112.15 [For SF] Overtime Fee. Upon a request from a person or firm for an inspection
 4 that is not scheduled during an employee's normal working schedule, an overtime fee will be
 5 charged. An overtime fee of ~~\$117.00~~\$128.00 per hour shall be collected. The minimum
 6 compensation will be four hours.

 8 Section 4. The San Francisco Fire Code is hereby amended by amending Appendix
 9 Chapter 1 Table 112-B to read as follows:

LEGISLATIVE DIGEST

[Fees for Fire Department Services]

Ordinance amending the San Francisco Fire Code by amending Appendix Chapter 1 Sections 112.8 and 112.15 and Table 112-B to increase fees for certain Fire Department services, and making environmental findings.

Existing Law

Sections 112.8 and 112.15 and Table 112-B of Appendix Chapter 1 of the San Francisco Fire Code specify fees for Fire Department inspection and plan review services.

Amendments to Current Law

The proposed legislation would amend Appendix Chapter 1 Section 112.8 to increase the fees for high-rise inspections. It would amend Appendix Chapter 1 Section 112.15 to increase the overtime fee for work outside an employee's normal work schedule. Finally it would amend Appendix Chapter 1 Table 112-B to increase fees for plan review services.

Background information

The current fees set in Sections 112.8 and 112.15 and Table 112-B do not cover the costs to the Fire Department of providing the services. The proposed fee increase will cover those costs.
