5 **\$175,000; the lawsuit was filed on November 20, 2009, in the United States District**
6 **Court for the Northern District of California, Case No. CV 09-5503 JSW; entitled Mark**
7 **Johnson, et al. v. City and County of San Francisco, et al.; the lawsuit involves an**
8 **employment dispute.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
12 authorizes the City Attorney to settle the action entitled Mark Johnson, et al. v. City and
13 County of San Francisco, et al., United States District Court for the Northern District of
14 California, Case No. CV 09-5503 JSW by the payment of \$175,000. The lawsuit involves an
15 employment dispute.

17 Section 2. The above-named action was filed in the United States District Court for the
18 Northern District of California on November 20, 2009, and the following parties were named in
19 the lawsuit: Plaintiffs: Mark Johnson, Franco S. Calzolari, Michael Bryant; Defendant: City and




