Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to accept and expend a grant in the amount of \$175,000 from the Department of Justice (DOJ), Office of Justice Programs (OJP), FY2006 Weed and Seed Program for the purpose of supporting activities to prevent, control and reduce violent crime, drug abuse, and gang activity in the designated Weed and Seed area in the Visitacion Valley neighborhood.

WHEREAS, MOCJ is the lead fiscal agency in administering the Weed and Seed Program; and

WHEREAS, San Francisco applied and was awarded on August 15, 2006, one-hundred seventy-five thousand dollars (\$175,000); and

WHEREAS, The Mayor's Office of Criminal Justice in partnership with the San Francisco Police Department, the Visitacion Valley Beacon Center and the U.S. Attorney's Office for the Northern District of California will be responsible for coordination and day-to-day operations of the planning and implementation phases of this grant; and

WHEREAS, MOCJ will be responsible for the fiscal, programmatic and administrative reporting to OJP; now, therefore, be it

RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to accept and expend \$175,000 from the Office of Justice Programs, to administer the Weed and Seed Program.




