8 WHEREAS, The Mexican Museum ("Museum") filed a lawsuit against the City and  
9 County of San Francisco ("City") in the San Francisco Superior Court, Case No. CGC-22-  
10 599833 (the "Action"), alleging breach of a Purchase Agreement between the City and the  
11 Museum, among others, and a lease agreement between the City and the Museum for the  
12 rental by the Museum of a four-story parcel of the property located at 706 Mission Street in  
13 San Francisco; and

14 WHEREAS, The City and Museum wish to avoid the expense and uncertainty of  
15 litigation of the Action if possible; and

16 WHEREAS, The City and the Museum have tentatively agreed, subject to approval of  
17 the Board of Supervisors, that tolling the limitations period will permit the Museum to dismiss  
18 the Action without prejudice; and

19 WHEREAS, The City and the Museum have agreed that the limitations and time  
20 related defenses for claims by both parties shall be tolled pursuant to the terms set forth in the  
21 Tolling Agreement, now, therefore, be it

22 RESOLVED, That the Board of Supervisors hereby approves the Tolling Agreement,  
23 on file with the Clerk of the Board in Filed No. 230535, and authorizes the City Attorney to  
24 enter into such Agreement on behalf of the City and County of San Francisco.
