2 IMPLEMENTING THE PROVISIONS OF THE MEMORANDUM OF UNDERSTANDING
3 BETWEEN THE SUPERIOR COURT OF CALIFORNIA, COUNTY OF SAN FRANCISCO
4 AND THE MUNICIPAL EXECUTIVE ASSOCIATION

6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. The Board of Supervisors hereby implements the provisions of the
8 Memorandum of Understanding between the Superior Court of California, County of San
9 Francisco and the Municipal Executives Association (MOU). The provisions so implemented
10 are on file in the office of the Board of Supervisors.

11 Section 2: The General Fund of the City and County of San Francisco shall not be
12 used to fund any of the salary increases or benefits referred to in the MOU. The City shall not
13 be liable for any costs incurred in providing the wages and other benefits set forth in the
14 MOU. The City's obligation under this ordinance shall be limited to administering health and
15 retirement benefits and payroll processing. This paragraph shall not apply to the payment of
16 wages and benefits for those positions covered by this ordinance which are specifically
17 authorized and funded by the City budget.

18 Section 3: The City's obligations described herein are not intended to create a dual
19 employer relationship.


