3 ENDORSING THE TRANSFER OF STATE GENERAL FUNDS FROM THE STATE TO
4 THE CALIFORNIA MENTAL HEALTH DIRECTORS ASSOCIATION FOR A CONTRACT
5 TO PROVIDE SERVICES TO FOSTER CARE AND OTHER MEDI-CAL ELIGIBLE
6 CHILDREN PLACED OUTSIDE OF SAN FRANCISCO.

7 WHEREAS, In order to improve access to services for foster care and other Medi-Cal
8 eligible children and youth who are placed outside of San Francisco County, the San Francisco
9 Department of Public Health has developed a contract with the County Mental Health Directors
10 Association to gain access to a statewide provider network managed by Value Options, a
11 national behavioral health company; and,

12 WHEREAS, In order to implement the contract, the City must authorize the State
13 Department of Mental Health to transfer to the County Mental Health Directors Association
14 \$88,550 from the state general funds designated for distribution to San Francisco to provide
15 Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services in FY 1999-2000;
16 and,

17 WHEREAS, These monies will be matched by Medi-Cal Federal Financial Participation
18 of \$94,670 for total funding of \$183,220; and,


19 WHEREAS, These monies will fund provider certification, contracting, services and
20 claims payment, authorized on behalf of San Francisco County Medi-Cal beneficiaries by Value
21 Options through their contract with the California Mental Health Directors Association, to
22 improve access to mental health treatment for foster care and other San Francisco MediCal
23 beneficiaries placed outside of San Francisco county; now, therefore, be it

24 RESOLVED, That the Board of Supervisors adopt this resolution authorizing the State
25 Department of Mental Health to transfer to the County Mental Health Directors Association
\$88,550 from the state general funds designated for distribution to San Francisco to provide

1 Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) services in FY 1999-2000;
2 and, be it

3 FURTHER RESOLVED, That these monies are to be used to fund administrative
4 services including provider certification, contracting, services and claims payment, authorized on
5 behalf of San Francisco County Medi-Cal beneficiaries by Value Options through their contract
6 with the California Mental Health Directors Association.


