

1 [Planning Code - Landmark Designation - Duboce Triangle Greek Revival Home]

3 **Ordinance amending the Planning Code to designate the Duboce Triangle Greek**
 4 **Revival Home, located at 2173 15th Street, Assessor's Parcel Block No. 3560, Lot No.**
 5 **022, on the south side of 15th Street between Noe Street and Sanchez Street, as a**
 6 **landmark consistent with the standards set forth in Article 10 of the Planning Code;**
 7 **affirming the Planning Department's determination under the California Environmental**
 8 **Quality Act; and making public necessity, convenience, and welfare findings under**
 9 **Planning Code, Section 302, and findings of consistency with the General Plan, and the**
 10 **eight priority policies of Planning Code, Section 101.1.**

18 Be it ordained by the People of the City and County of San Francisco:

19 Section 1. Findings.

20 (a) Environmental and Land Use Findings.

21 (1) The Planning Department has determined that the Planning Code
 22 amendment proposed in this ordinance is subject to a Categorical Exemption from the
 23 California Environmental Quality Act (California Public Resources Code Sections 21000 et
 24 seq., hereinafter "CEQA") pursuant to Section 15308 of California Code of Regulations, Title
 25 14, Sections 15000 et seq., the Guidelines for implementation of the statute, for actions by

1 regulatory agencies for protection of the environment (in this case, landmark designation).
2 Said determination is on file with the Clerk of the Board of Supervisors in File No.
3 _____ and is incorporated herein by reference. The Board of Supervisors affirms
4 this determination.

5 (2) Pursuant to Planning Code Section 302, the Board of Supervisors finds that
6 the proposed landmark designation of the Duboce Triangle Greek Revival Home will serve the
7 public necessity, convenience, and welfare for the reasons set forth in Historic Preservation
8 Commission Resolution No. _____, recommending approval of the proposed
9 designation, which is incorporated herein by reference.

10 (3) The Board of Supervisors finds that the proposed landmark designation of
11 the Duboce Triangle Greek Revival Home is consistent with the General Plan and with
12 Planning Code Section 101.1(b) for the reasons set forth in Historic Preservation Commission
13 Resolution No. _____, which is incorporated herein by reference.

14 (b) General Findings.

15 (1) On March 6, 2026, the Board of Supervisors adopted Resolution No. 097-
16 26, initiating landmark designation of the Duboce Triangle Greek Revival Home as a San
17 Francisco landmark pursuant to Section 1004.1 of the Planning Code. On March 6, 2026, the
18 Mayor approved the resolution. Said resolution is on file with the Clerk of the Board of
19 Supervisors in File No. 260050.

20 (2) Pursuant to Charter Section 4.135, the Historic Preservation Commission
21 has authority “to recommend approval, disapproval, or modification of landmark designations
22 and historic district designations under the Planning Code to the Board of Supervisors.”

23 (3) The Landmark Designation Fact Sheet dated May 20, 2026 was prepared
24 by Planning Department Preservation staff. All preparers meet the Secretary of the Interior’s
25 Professional Qualification Standards for historic preservation program staff, as set forth in

1 Code of Federal Regulations Title 36, Part 61, Appendix A. The report was reviewed for
2 accuracy and conformance with the purposes and standards of Article 10 of the Planning
3 Code. A copy of the Landmark Designation Fact Sheet is on file with the Clerk of the Board of
4 Supervisors in File No. _____ and is incorporated herein by reference.

5 (4) The Historic Preservation Commission, at its regular meeting of May 20,
6 2026, reviewed Planning Department staff’s analysis of the historical significance of the
7 Duboce Triangle Greek Revival Home set forth in the Landmark Designation Fact Sheet.

8 (5) On May 20, 2026, after holding a public hearing on the proposed
9 designation and having considered the specialized analyses prepared by Planning
10 Department staff and the Landmark Designation Fact Sheet, the Historic Preservation
11 Commission recommended designation of the Duboce Triangle Greek Revival Home as a
12 landmark consistent with the standards set forth in Section 1004 of the Planning Code, by
13 Resolution No. _____. Said resolution is on file with the Clerk of the Board in File No.
14 _____.

15 (6) The Board of Supervisors hereby finds that the Duboce Triangle Greek
16 Revival Home has a special character and special historical, cultural, architectural, and
17 aesthetic interest and value, and that its designation as a landmark will further the purposes of
18 and conform to the standards set forth in Article 10 of the Planning Code. In doing so, the
19 Board hereby incorporates by reference the findings of the Landmark Designation Fact Sheet.

20
21 Section 2. Designation.

22 Pursuant to Section 1004.3 of the Planning Code, the Duboce Triangle Greek Revival
23 Home, located at 2173 15th Street, Assessor’s Parcel Block No. 3560, Lot No. 022, is hereby
24 designated as a San Francisco landmark consistent with the standards set forth in Section
25

1 1004. Appendix A to Article 10 of the Planning Code is hereby amended to include this
2 property.

3
4 Section 3. Required Data.

5 (a) The description, location, and boundary of the landmark site consists of the
6 footprint of the Duboce Triangle Greek Revival Home, located on Assessor's Parcel Block No.
7 3560, Lot No. 022, on the south side of 15th Street between Noe Street and Sanchez Street in
8 San Francisco's Castro/Upper Market neighborhood, as shown in the Landmark Designation
9 Fact Sheet.

10 (b) The characteristics of the landmark that justify its designation are described and
11 shown in the Landmark Designation Fact Sheet and other supporting materials contained in
12 Planning Department Record Docket No. 2026-001905DES. In brief, the Duboce Triangle
13 Greek Revival Home, located at 2173 15th Street, is eligible for local designation as an intact
14 expression of the Greek Revival style in San Francisco and represents a pre-Victorian form
15 and style that is rare in San Francisco. The property is amongst the earliest homes in Duboce
16 Triangle and provides a tangible connection to early residential development outside of San
17 Francisco's center city core. It remains largely intact with characteristic Greek Revival
18 features, including its forward-facing gabled roof and full-width entry porch.

19 (c) The particular features that should be preserved, or replaced in kind as determined
20 necessary, are those generally shown in photographs and described in the Landmark
21 Designation Fact Sheet, which can be found in Planning Department Record Docket No.
22 2026-001905DES, and which are incorporated in this designation by reference as though fully
23 set forth herein. This designation does not identify any interior character-defining features.
24 Specifically, the features that are character-defining and shall be preserved or replaced in kind
25

1 are the exterior elevations, form, massing, structure, rooflines, architectural ornament, and
2 materials of the property identified as:

- 3 (1) Location of the house on the property with front setbacks;
- 4 (2) Two-story height over basement;
- 5 (3) Forward facing gable roof with angled raking cornice;
- 6 (4) Rectangular plan;
- 7 (5) Continuous porch supported by square posts with Tuscan capitals and left front
8 entry door;
- 9 (6) Double hung wood window, with Italianate style hood and casings around upper
10 story front façade window; and
- 11 (7) Wood construction.

12
13 Section 4. Effective Date.

14 This ordinance shall become effective on the 31st day after enactment. Enactment
15 occurs when the Mayor signs the ordinance, the Mayor returns the ordinance unsigned or
16 does not sign the ordinance within ten days of receiving it, or the Board of Supervisors
17 overrides the Mayor’s veto of the ordinance.
