3 **Ordinance authorizing settlement of the lawsuit filed by Bruno Mincin against the City**  
4 **and County of San Francisco for \$140,000; the lawsuit was filed on June 25, 2024, in**  
5 **San Francisco Superior Court, Case No. CGC-24-615897; entitled Bruno Mincin v. City**  
6 **and County of San Francisco, et al; the lawsuit involves alleged personal injury on a**  
7 **City sidewalk.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Bruno Mincin v. City and County of  
12 San Francisco, et al, San Francisco Superior Court, Case No. CGC-24-615897 by the  
13 payment of \$140,000. The lawsuit involves alleged personal injury on a City sidewalk.

14 Section 2. The above-named action was filed in San Francisco Superior Court on June  
15 25, 2024, and the following parties were named in the lawsuit: Plaintiff Bruno Mincin;  
16 Defendant City and County of San Francisco.
