8 WHEREAS, On September 2, 2003, the Director of the Department of Parking and
9 Traffic, after ISCOTT's decision to deny the requested temporary closure was appealed to the
10 Department, disapproved the request of the Immigrant Rights Movement for the temporary
11 closure of Mission Street, between 24th and 25th Streets, on ~~October 25, 2003~~ October 26,
12 2003 (7am to 7pm), for Immigrant Pride Day; and,

13 WHEREAS, On September 3, 2003, the Immigrant Rights Movement, through Carlos
14 Petroni, filed an appeal of the Department's decision to the Board of Supervisors, under the
15 provisions of Section 801 of the San Francisco Traffic Code; and,

16 WHEREAS, The appellants sought to reverse the decision of the Director and have the
17 permit issued, and also sought to achieve a reduction in the fees that would be charged by the
18 City for the conduct of the event; and,

19 WHEREAS, Section 801 of the Traffic Code requires that the appeal be scheduled for
20 the next regularly scheduled meeting of the Board of Supervisors, in conformance with public
21 notice requirements, and that meeting is September 16, 2003; and,

22 WHEREAS, On September 16, 2003, the Board of Supervisors conducted the hearing
23 on the appeal and considered all of the public testimony presented by all interested persons,
24 both oral and written; now, therefore, be it


