3 **Ordinance amending Ordinance No. 1061 entitled “Regulating the Width of Sidewalks”**  
4 **by adding thereto Section 1590 to change the official sidewalk width of Mason Street**  
5 **starting at the southwest corner of the intersection of Mason Street and Washington**  
6 **Street and continuing south 29.52 feet; making environmental findings and findings**  
7 **pursuant to the General Plan and Planning Code Section 101.1; requiring relocation,**  
8 **modification, or both of facilities affected by the sidewalk width change.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. The Board of Supervisors adopts as its own and incorporates by reference herein  
14 as though fully set forth the Planning Department findings in its letter dated June 23, 2011.

15 Said letter stated the actions contemplated herein are consistent with the General Plan and in  
16 conformance with the Eight Priority Policies of Planning Code Section 101.1. A copy of said  
17 letter is in the Clerk of the Board of Supervisors File No. \_\_\_\_\_.

18 Section 2. In the abovementioned letter, the Planning Department also determined that  
19 the actions contemplated in this Ordinance are in compliance with the California  
20 Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said  
21 determination is incorporated herein by reference.

22 Section 3. In accordance with the Department of Public Works’ Order No. 179,498,  
23 a copy of which is in the Clerk of the Board of Supervisors File No. \_\_\_\_\_ and  
24 incorporated herein by reference, Board of Supervisors Ordinance No.1061, entitled  
25 “Regulating the Width of Sidewalks,” a copy of which is in the Clerk of the Board of

1 Supervisors Book of General Ordinances, in effect May 11, 1910, is hereby amended by  
2 adding thereto a new section to read as follows:

3 Section 1590. The official sidewalk width of Mason Street starting at the south west corner of  
4 the intersection Mason Street and Washington Street and continuing South for 29.52 feet shall be as  
5 shown on Department of Public Works drawing Q-20-696, of which is in the Clerk of the Board of  
6 Supervisors File No. \_\_\_\_\_.

7 Section 4. The City and County of San Francisco, as is necessary as a result of this  
8 Ordinance, shall make arrangements with public utility companies and City Departments for  
9 the relocation, and/or modification of any affected public facilities. Any necessary relocation,  
10 modification, or both of such facilities shall be at the cost of the owner of the utility.
